










Effectively apply Ecosystem Based Management

- Pacific Integrated Island Management Case Studies and Guidelines (UNEP-SPREP project with Australian Aid)
- 2. Marine Spatial Planning (MSP) projects at regional and national scale.
- 3. Spatial Planning Officer appointed for the region.
- 4. Implemented ecosystem based adaptation projects in Fiji, Solomon Islands, Samoa, Vanuatu and Kiribati
- 5. Global Ocean Acidification Experts Workshop









2. GPA: Protection from Land Based Activities

- 1. AFD Regional Solid Waste management Initiative 2011-2015 cost-benefit of disposal options for used oil (re-use for power generation was best).
- 2. Basil Convention and Waigani Convention projects: used oil, and E-waste management cost options; hazardous waste management training.
- 3. Marine debris adviser appointed at SPREP in 2014.
- 4. New position "Marine Pollution Officer" placed at SPREP on secondment from Australian Marine Safety Authority.
- 5. SPREP-KIOST assessment of waste disposal sites on marine water quality.







2. (continued) GPA:

Protection from Land Based Activities

- 5-yr GEF programme on hazardous waste management (USD2.5M) commenced. Nov 2013.
- Pacific Islands Regional Marine Spill Contingency
 Plan (PACPLAN) updated and endorsed Sept 2013.
- Training on investigating illegal discharge from vessels.
- National oil spill training and NTPLANs (Nauru, Solomon Islands, Tonga, Samoa).
- Regional workshop International Convention on Control of Harmful Anti-fouling Systems on Ships.
- Ballast Water Management Compliance Monitoring
 & Enforcement training.










3. Strengthen capacity for coastal and marine governance

- Vision and Framework for a "Pacific Oceanscape" with partner CROP agencies.
- SPREPs change management process has more than doubled financial & technical support to Pacific Island members.
- Regional Briefing Document on BBNJ for PICs, including monitoring issues and SDGs for the high seas (ABNJ).
- Collaborations to improve surveillance and data for marine debris, threatened and migratory species.
- Partnerships with regional CROP agencies and interregionally, eg, with Indian Ocean Commission, 5Cs and others.
- Networks of marine protected areas (Samoan Archipelago)









4. Promote resource efficiency & productivity

- Pacific ACP States 4th Regional Training Workshop "Environmental Perspectives of Deep Sea Mineral Activities"
- Regional & national efforts on potential impacts of Deep Seas Minerals (DSM) activities to biodiversity.
- Implementing precautionary approaches, developing policies (eg EIA) and systems (eg, MSP) to address DSM exploration and mining.
- Promoting "green & blue economy" solutions for sustainable use of coastal and marine resources.
- "Blue Days" project with French Territories tourism industry sectors in conservation of migratory whales, sea turtles and coastal waters.









5. Strengthen coordination and capacity for state of marine environment reporting

- 1. Joint MEA Pre-COP workshop and training (CBD, CMS, Ramsar, CITES)
- 2. Pacific Islands Framework for Nature Conservation & Protected Areas aligned to Aichi 2020 targets
- 3. Assisting SOCO and SoE Reports for countries using Minimum Environmental Indicators








Strengthen mechanisms for MEA,UN and IFI collaboration
