

Post-Rio to Post-2015: Planning International Stakeholder Engagement

Organised by UNEP, UNDESA, Stakeholder Forum and The Green Economy Coalition

Objective of the event

The two-day meeting will provide an opportunity for Major Groups and Stakeholders from across the globe to discuss the post Rio+20 and move forward the post-2015 development agenda. In particular international representatives of Major Groups and stakeholders will:

- Discuss the new sustainable development governance setting in a post Rio+20 context, the potential role of Major Groups, and the space for engagement - moving from multi-stakeholder consultations to multi-stakeholders governance, from local to global levels and vice-versa;
- Discuss how to further the green economy agenda and the role of Major Groups in relevant policies and actions, including the Ten Year Framework of Programmes on Sustainable Consumption and Production Patterns (the “10YFP”);
- Look forward to post-2015 and map how stakeholder engagement in the process (international, national and local) can be enhanced to determine the UN post-2015 development framework, in particular looking at the Sustainable Development Goals (SDGs) and the role of Major Groups in their design and implementation.

The meeting will identify potential entry points for stakeholders in the follow-up processes of Rio+20 and how to actualize multi-stakeholder engagement in these processes and subsequent fora.

The co-chairs for the event will be Farooq Ullah (Executive Director, Stakeholder Forum) and Oliver Greenfield (Convener, Green Economy Coalition).

Expected Outcomes

The meeting will result in a series of statements and messages to political leaders and decision makers on sustainable development post 2015 and beyond.

The meeting will inform UNEP’s Global Major Groups and Stakeholders about the upcoming Governing Council in February 2013, and the 20th Session of the Commission on Sustainable Development (CSD 20) in May 2013.

Expected Outputs

There are several expected outputs from this event. These are:

1. A co-chairs’ statement.
2. Recommendations and messages to UNEP Governing Council in February 2013 and to CSD 20 in May 2013.
3. A wrap-up edition of Stakeholder Forum’s multi-stakeholder magazine ‘Outreach’, which will summarize the meeting’s outcomes and provide space for discourse on the meeting’s themes.

Event Themes

The event will discuss the below five themes. These themes will provide the structure for the event's proceedings.

1. The new **governance architecture** post Rio+20, and the potential role of Major Groups, and the space for engagement from local to global levels, mainly High-Level Political Forum (HLPF) established at Rio+20;
2. **Sustainable Development Goals (SDGs) and the post-2015 development agenda**, including the role of Major Groups in their design and implementation;
3. The **green economy** in the context of sustainable development and poverty eradication, including Beyond GDP;
4. The 10 Year Framework of Programmes on Sustainable Consumption and Production (**10YFP on SCP**);
5. A focus on **implementation and delivery** of the Rio+20 outcomes, including mobilization of finance, technology and resources.


**Directions to conference venue: Pace University, Michael Schimmel Center for the Arts

Directions from the airport to central Manhattan

- From JFK International Airport to Pace University (approx. 1 hour)
- Take the AirTrain to Howard Beach
- At Howard Beach Station take the A train from towards Inwood- 207 St. to Fulton Street stop
- Get off at Fulton Street stop, continue east towards William Street
- Turn left onto William Street and walk straight until you arrive at Pace University.

From LaGuardia Airport to Pace University (approx. 1 hour & 15 mins)

- Catch the M60 bus towards West Side BWay- 106 St via 125 St from the terminal
- Get off at Hoyt Av/31 St and walk to Astoria Blvd
- Take the N train towards Coney Island- Stillwell Av
- Get off at City Hall stop and exit onto Broadway
- Continue south for 2 blocks and turn left onto Ann Street
- Continue east for 3 blocks until you reach Pace University

From Newark Liberty International Airport to Pace University (approx. 1 hour)

- Catch a New Jersey Transit train towards New York Penn Station
- Get off at Newark train station stop
- Take the PATH train towards World Trade Center
- Get off at World Trade Center stop and continue east on Fulton Street for 3 blocks
- Turn left onto William Street and walk straight until you arrive at Pace University.

From New York Penn Station to Pace University (approx. 15 mins)

- Walk to 34 St- Penn Station
- Take train 2 towards Flatbush Av- Brooklyn College or train 3 towards New Lots Av
- Get off at Fulton Street stop
- Turn north onto William Street and walk straight until you arrive at Pace University.

From Grand Central Terminal to Pace University (approx. 15 mins)

- Walk to Grand Central- 42 St
- Take train 4 towards Crown Hts- Utica Av or train 5 towards Flatbush Av- Brooklyn College
- Get off at Brooklyn Bridge- City Hall stop
- Walk south on Centre Street
- Turn left onto Spruce Street
- Turn left onto William Street and walk straight until you arrive at Pace University.
