**Existing Guidelines on Marine Litter Management** 

For environmental and economic reasons, this document is printed in a limited number. Delegates are kindly requested to bring their copies to meetings and not to request additional copies.

1. Article 14 of the Regional Plan on Marine Litter Management in the Mediterranean (Decision IG.21/7) foresees that the Secretariat in cooperation with relevant international and regional organizations, shall prepare specific guidelines taking into account where appropriate existing guidelines, to support and facilitate the implementation of measures provided for in articles 9 and 10 of the Regional Plan. Article 12, point 4 also provides for the Secretariat to prepare in collaboration with the relevant regional organizations the guidelines for the preparation of the National Marine Litter Monitoring Programmes.

2. In order to implement the above provisions, UNEP/MAP Barcelona Convention Secretariat has programmed its work to identify, develop and update relevant guidelines which addresses specific aspects of marine litter management. The first steps that have been already undertaken are:

- Elaboration and adoption by COP 19 of the Marine Litter Monitoring Programme and its Guidance document;
- Elaboration and adoption by COP 19 of the Fishing for Litter Guidelines;
- Identification of existing guidelines addressing specific marine litter management developed at global and regional for a including the other regional seas.

3. The guidelines on marine litter management shall facilitate the implementation of measures provided for in Articles 9 and 10 of the Regional Plan on Marine Litter Management in the Mediterranean, addressing both the land based and sea based sources of marine litter.

4. In this respect and based on the specific provisions of the above articles, the new and or updated or existing guidelines are expected to cover the following marine litter management tools:

- Application of Extended Producer Responsibility;
- Application of Sustainable Procurement Policies;
- Establishment of voluntary agreements with retailers and supermarkets to reduce plastic bags consumption and introduce bulk and refill special and reusable containers for selling dry food;
- Use of fiscal and economic instruments to promote the reduction of plastic bag consumption;
- Establishment of Deposits, Return and Restoration System for expandable polystyrene boxes in the fishing sector and for beverage packaging
- Establishment of procedures and manufacturing methodologies together with plastic industry, to minimize the decomposition characteristics of plastic to reduce micro-plastics;
- Application of waste reducing/reusing/recycling with the view to reduce the fraction of plastic packaging waste that goes to landfill or incineration without energy;
- *Reduction at source of urban solid waste management;*
- Ways and means to charge reasonable cost for the use of port facilities or when applicable a No-Special-Fee system;
- Use "Gear marking to indicate ownership" and the "reduce ghost catches through the use of environmental neutral upon degradation of nets, pots and traps" concepts;
- Preventing marine littering from dredging activities and from littering on the beach, illegal sewage disposal in the sea, the coastal zone and rivers.

5. The Secretariat undertook a research and identified a list of existing global and or regional guidelines on marine litter management as presented in Annex I to this document. This list covers different aspects such as monitoring, waste management, fishing for litter, etc. Identification of such a list is a first effort and will be followed up by a joint review and further contribution and inputs by all the partners as appropriate. On this basis consideration will be given to the needs for further update or elaboration of necessary common tools, guidelines and best practices for implementation of prevention and reduction marine litter measures.
