In November last year, for the first time in Africa, a harmonized road map for sustainable transport was adopted. This was the outcome of the 1st Ministerial and Experts Conference of the newly established **Africa Sustainable Transport Forum** (ASTF). The Conference which was opened by the Honorable President Uhuru Kenyatta of Kenya and UN Secretary General Mr. Ban Kimoon, at UNEP Headquarters in Nairobi, Kenya, brought together over 250 participants representing 43 African Countries.

The ASTF Secretariat now housed at UNEP and supported by UN-Habitat, the World Bank and UNEP, is working to secure wide uptake of the Action Framework across Africa and catalyse activities to achieve more sustainable transport on the ground.

The goal of the ASTF Secretariat is to support countries to integrate sustainable transport into the region's development and planning processes, and increase the amount of funding going to sustainable transport programs in Africa.





ASTF ACTION FRAMEWORK UPTAKE AND DISSEMINATION — OVERVIEW OF RECENT ACTIVITIES

-International Road Federation (IRF) 'Road Safety Challenge for Africa' -Addis Ababa, Ethiopia. March 11 - 12

The IRF held an event at the African Union Headquarters in Ethiopia on the subject of 'Accomplishing Targets of Road Safety in Accordance with the Decade of Action Plan' - during which the ASTF Action Framework was presented in the context of the 'Road Safety' action area and UNEP's Share the Road Programme.

-African Ministerial Conference on the Environment (AMCEN) – Cairo, Egypt. March 2 – 6.

The ASTF Secretariat has secured agreement from 15th Ordinary Session of the African Ministerial Conference on the Environment held in Cairo from March 2 – 6, 'to implement the priority transport areas outlined in the Africa Sustainable Transport Forum Action Framework to address road safety, reduce vehicle emissions and improve energy efficiency and enhance sustainable urban transport as a means of effectively implementing the sustainable development agenda;'. A commitment to the implementation of the ASTF Action Framework by the African Environment Ministers was included in the Cairo Declaration.

-Fourth World Bicycle Forum (FMB4) - Medellin, Colombia. February 26 - March 1.

The ASTF was presented at the 4th World Bicycle Forum held in Medellin Colombia, February 26 – 1 March, in the context of challenges to non-motorised transport in developing countries.

-Friedrich Ebert Stiftung (FES) 'Exploring Sustainable Low Carbon Development in Tanzania' - Dar es Salaam. February 27 – 28.

FES together with Brot für die Welt, Act Alliance, WWF and Climate Action Network (CAN) held a Workshop in Tanzania focusing on energy and transport sectors in Tanzania, as sectors with significant potential for promoting low carbon development. The ASTF was presented under the theme of low carbon development initiatives, opportunities and sustainable transport in East Africa and how civil society organisations can add value.

- 2nd Annual East Africa Transport & Infrastructure Conference - Nairobi, Kenya, July 8 -9 2015

A 2-Day event focusing on the development of transport infrastructure in Eastern Africa Region. ASTF was presented in the context of an initiative guiding sustainable transport infrastructure development across Africa and ultimately working towards increasing the amount of funding going towards sustainable transport in Africa.

- BRT, BHLS and Paratransit - From Project to Policy' Lome, Togo. September, 2015.

As part of a launch event for a new Masters Programme (Transport et Mobilité Durable dans les Villes Africaines) at EAMAU Togo, CODATU organized a one day seminar focused on road based networks in African cities. ASTF was presented in the context of setting technological solutions in the larger picture for a transition to more sustainable transport on an Africa-wide level.


