## Summary

The present note provides information on follow-up to General Assembly resolution 67/226. It outlines the measures taken and progress achieved by the United Nations Environment Programme as a non-resident organization of the United Nations system in implementing the management process for the implementation of the resolution.

- 1. General Assembly resolution 67/226, on the quadrennial comprehensive policy review of operational activities for the development of the United Nations system, emphasized the importance attached by Member States to enhanced system-wide coherence as a strategy for improving the effectiveness of the United Nations development system as a whole.
- 2. In line with the main thrust of the resolution, at the heart of the United Nations Environment Programme (UNEP) medium-term strategy for the period 2014–2017 are objectives of greater efficiency, greater transparency and the enhanced use of performance information for improved management decision-making. In setting out the programmes of work for the bienniums 2014–2015 and 2016–2017, UNEP took into account the quadrennial review recommendations for improving United Nations effectiveness, efficiency, coherence and impact on development in developing countries. UNEP is paying particular attention to ways in which it can leverage further impact through development cooperation and country-level modalities of the United Nations system, including by increasing its participation in United Nations country teams. Capacity-building and the facilitation of technology development and sharing in countries underpins the delivery of all UNEP support to countries, in line with the Bali Strategic Plan for Technology Support and Capacity-building.
- 3. The quadrennial review and resolution 67/226 set new standards for assessing the effectiveness, efficiency and coherence of United Nations operational development activities. Key features of the resolution include:
  - (a) Some 178 mandates requiring action by various actors;
- (b) Some 143 mandates addressed to United Nations system entities, including 22 to the Secretary-General; 4 to United Nations resident coordinators and country teams; and 9 to the Economic and Social Council, the executive boards of funds and programmes and the governing bodies of the specialized agencies;
- (c) Some 42 actions that are time-specific, 29 that require reporting and 20 that involve the development of policies and processes.
- 4. With the resolution, the General Assembly has formulated a strategic direction for the United Nations development system that includes what needs to be achieved and how United Nations entities will need to function in order successfully to support programme countries in a changing development landscape.
- 5. There is also a strong intergovernmental recognition of the United Nations "Delivering as one" model, although it remains a voluntary nationally-led option. As at March 2014, 37 countries had formally requested the United Nations to adopt the "Delivering as one" approach to their development assistance. From 2007 until the end of 2013, UNEP supported the mainstreaming of environmental sustainability into 96 United Nations development assistance frameworks. For the 2014–2016 programming cycle, over 100 development assistance frameworks will be prepared. Throughout its programmes of work, UNEP articulates its planned engagement in operational activities for development in each of the subprogrammes.
- 6. In the resolution, the General Assembly requested the funds and programmes of the United Nations to implement decisions in a number of areas through time-bound actions, requiring United Nations entities and inter-agency mechanisms to ensure timely and full implementation. Several key steps have already been taken to improve the effectiveness, efficiency, coherence, relevance and impact of United Nations operational activities in the area of development.
- 7. At the intergovernmental level, in resolution 68/1 the General Assembly agreed upon far-reaching measures to strengthen the Economic and Social Council, including, among other means, by changing the timing of its operational activities for development segment within the Council cycle. Those measures aim to enable the Council to provide better overall coordination and guidance to operational development funds and programmes on a system-wide basis, including with regard to objectives, priorities and strategies in the implementation of the policies formulated by the Assembly. The UNEP Executive Director, in his capacity as Chair of the High-level Committee on Programmes of the United Nations System Chief Executives Board for Coordination, addressed the Economic and Social Council operational activities for development segment in February 2014.
- 8. In response to the request of the Council in its resolution 2013/5, a new single coherent quadrennial review monitoring and reporting framework has been developed by the Department of Economic and

Social Affairs, the United Nations Development Group and other United Nations entities, with full ownership by the United Nations development system. The framework contains a set of 99 results-oriented indicators that respond to the General Assembly's request for actions, including those with detailed timelines. It has direct linkages to the new strategic plans of the funds and programmes, which have been aligned with the quadrennial review.

- 9. Resolution 67/226 provides clear and constructive guidance to the United Nations system on the need to increase its efficiency, transparency and cost effectiveness. Overall, the resolution includes the following key messages:
- (a) System-wide coherence should be enhanced, and the "Delivering as one" approach was formally recognized;
- (b) It is important to increase the efficiency of United Nations operational activities for development;
  - (c) Trends in the core/non-core funding imbalance are not sustainable;
- (d) The accountability of the United Nations development system to Member States regarding results and impacts requires strengthening;
- (e) Sustainable development should be mainstreamed into United Nations development operations;
- (f) Normative and operational linkages in the United Nations development system need to be strengthened.
- 10. The United Nations Development Group has developed a common action plan for the implementation and monitoring of resolution 67/226. While all quadrennial review mandates will be addressed by the funds, programmes and agencies of the United Nations, as appropriate, the United Nations Development Group action plan endeavours to prioritize those mandates for collective action by the Group. The action plan focuses on 28 main priority areas. UNEP contributes to the action plan though its participation in global, regional and national inter-agency coordination mechanisms.
- 11. The following table, which is based on a matrix prepared by the Office for Economic and Social Council Support and Coordination of the Department of Economic and Social Affairs, lists some of the operative paragraphs of resolution 67/226 in response to which specific follow-up might be considered.
