
### **Call to Action**

UNEP cannot do its work without secure, stable, adequate, and increased financial resources (SSAIFR). Ninety-five per cent of our funding comes from voluntary contributions, which depend on the goodwill of the Member States and other partners who champion our mission.

The Environment Fund is the main source of funding for UNEP's Programme of Work. By leveraging resources for all of our programmes across national boundaries and thematic issues, the Fund enables UNEP to work in an effective and efficient manner to implement governments' joint decisions. By contributing to the Environment Fund, your government can empower UNEP to provide critical leadership and promote international cooperation on the environment. The Environment Fund is complemented by earmarked funding, which is especially valuable at the programme level and in cases where direct contributions to the Environment Fund are simply not possible.

All 193 member states are expected to contribute to the Environment Fund in the spirit of universal membership – global responsibility.
