# Annotations to the provisional agenda

### **Item 1: Opening of the session**

1. The eleventh special session of the Governing Council/Global Ministerial Environment Forum of the United Nations Environment Programme (UNEP) will be opened at 10 a.m. on Wednesday, 24 February 2010, at the Bali International Conference Centre, Bali, Indonesia, by the President of the Council/Forum or, in his absence, by one of the other officers of the Council/Forum at its twenty-fifth session.

#### **Item 2: Organization of work**

#### Item 2 (a): Election of officers

- 2. In accordance with rules 18 and 19 of the rules of procedure of the Governing Council, at its opening plenary meeting the Council/Forum will elect two Vice-Presidents, one nominated by the African group and the other by the Latin American and Caribbean group.
- 3. This election is required as a result of the election of 29 member States of the Governing Council conducted by the General Assembly at its sixty-fourth session, in November 2009. As a result of those elections, Algeria, the Vice-President of the Governing Council elected at its twenty-fifth session and nominated by the African group as its representative, ceased to be a member of the Governing Council as from 1 January 2010. Consequently, the representation of the African group on the Bureau fell vacant on 1 January 2010, with the need to maintain equitable geographical representation within the Bureau requiring such election.
- 4. This election is also to confirm the nomination by the Latin American and Caribbean group, via a letter from the Permanent Mission of Brazil to UNEP dated 23 November 2009, to replace the incumbent Vice-President elected at the twenty-fifth session and nominated by the group as its representative.
- 5. The amendment to the provisional agenda as adopted by the Council/Forum at its twenty-fifth session to include the present item was approved by the Bureau at its meeting on 24 November 2009

and has been communicated to all Governments in the notification by the Executive Director of the eleventh special session.

## Item 2 (b): Adoption of the agenda

6. The Council/Forum will adopt its agenda (UNEP/GCSS.XI/1). The provisional agenda, as adopted by the Council/Forum at its twenty-fifth session, and subsequently amended, has been distributed with the notification.

#### Item 2 (c): Organization of work

#### (a) Organization of work

- 7. Pursuant to section I of decision 25/17 and the subsequent decision by the Bureau, the eleventh special session will be held over three days, from 24 to 26 February 2010. Informal consultations in regional groups will be held on Tuesday, 23 February.
- 8. The Executive Director recommends that, following the election of officers and the adoption of its agenda, the Council/Forum at its plenary meeting on the morning of Wednesday, 24 February, should consider the organization of work under agenda item 2 (c). The Executive Director also recommends that the Council/Forum at its opening plenary meeting should establish sessional committees, including a committee of the whole.
- 9. The Executive Director further recommends that at its meeting on the morning of Friday, 26 February, the Council/Forum should hold a decision-making session to take necessary decisions, including any emerging from the ministerial consultations and the Committee of the Whole, together with issues of relevance to the Council/Forum emerging from the simultaneous extraordinary meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions, which are being held immediately prior to the current session of the Council/Forum. Participants will also review the President's draft summary of the ministerial consultations. Furthermore, participants will discuss General Assembly resolution 64/236 of 24 December 2009 on the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the outcomes of the World Summit on Sustainable Development and reflect on the outcome of the fifteenth session of the Conference of the Parties to the United Nations Framework Convention on Climate Change, including the implications for UNEP.
- 10. The Executive Director recommends that items 3 (credentials of representatives), 5 (other matters), 6 (adoption of the report) and 7 (closure of the session) should be considered during the plenary meeting on the afternoon of Friday, 26 February.
- 11. During the opening plenary meeting, the Executive Director will present his policy statement, as referred to in document UNEP/GCSS.XI/2. The statement will be made available to participants and placed on the relevant website following its delivery.
- 12. The proceedings of the Council/Forum, including its plenary meetings, the plenary meetings of the ministerial-level consultations and the Committee of the Whole, will be conducted with simultaneous interpretation into the six official languages of the United Nations.
- 13. In an endeavour to make the current session of the Council/Forum as climate-neutral and environmentally friendly as possible, various measures are in place. These include the offsetting of greenhouse gas emissions caused by participants' travel to and stay in Bali for participants sponsored by UNEP, communications campaigns and a reduction in the number of hard copies of all documents. Delegations will receive one copy each of all documents and delegates are encouraged to visit the relevant website and download any further copies required. A limited number of documents will be available during the session for any delegates wishing to receive additional copies. All participants are recommended to consider offsetting the greenhouse gas emissions caused by their travel to and stay in Bali

#### (b) Ministerial-level consultations

14. Pursuant to General Assembly resolution 53/242 of 28 July 1999, the Governing Council constitutes an annual ministerial-level global environmental forum to review important and emerging policy issues in the field of the environment. In view of this mandate, the Executive Director recommends that participants should meet in the form of ministerial-level consultations, beginning on the late morning of Wednesday, 24 February, with meetings continuing until the morning of Friday, 26 February, under the overall theme of "environment in the multilateral system".

- 15. The ministerial-level consultations will begin in the form of the first plenary meeting in the late morning of Wednesday, 24 February, which will be a scene-setting session at which ministers will be provided with a comprehensive update on environment within the multilateral system. It will be followed by two plenary meetings on the afternoons of Wednesday and Thursday, 24 and 25 February, on the topics of "international environmental governance and sustainable development" and "biodiversity and ecosystems", respectively. The ministerial consultations on the morning of Thursday, 25 February, will be held in five parallel round-table discussions on the topic of the "green economy". The plenary meeting on the morning of Friday, 26 February, will be a decision-making session, at which participants will discuss issues as mentioned in paragraph 9, above.
- 16. The Executive Director will submit three background papers to facilitate the discussion of the ministerial-level consultations on each topic listed above (documents UNEP/GCSS.XI/10 and Add.1 and Add.2). The President's summary of the ministerial consultations at the twenty-fifth session of the Council/Forum has been reproduced for ease of reference (UNEP/GCSS.XI/INF/9) and an information note on the composition of the round tables to be held on the morning of Thursday, 25 February, will be made available (UNEP/GCSS.XI/INF/10).
- 17. A special ministerial-level working breakfast meeting will be held on the early morning of Thursday, 25 February, to discuss the relationship between UNEP and the Commission on Sustainable Development at its eighteenth session. A background note will be made available to facilitate the discussion (UNEP/GCSS.XI/INF/7). This discussion will be further complemented by relevant special events aligned to the themes of the ministerial consultations.

#### (c) Committee of the Whole

- 18. The Committee of the Whole, if established, is expected to begin its work during the afternoon of Wednesday, 24 February. The Committee will elect its own officers in accordance with rule 61 of the rules of procedure, noting that the Council/Forum will designate one of its Vice-Presidents as the Chair.
- 19. The Executive Director recommends that the Committee should take up agenda item 4 (Emerging policy issues: environment in the multilateral system). Substantive topics to be discussed by the Committee and the relevant documents are set out below.
- 20. It is envisaged that the Committee will conclude its work during the afternoon of Thursday, 25 February with the adoption of its report. The report will be submitted to the Council/Forum in plenary meeting for adoption.

#### (d) Pre-session meetings and events and relevant events and functions

- 21. The eleventh special session of the Council/Forum will be preceded by the eleventh Global Major Groups and Stakeholders Forum, to be held on Sunday and Monday, 21 and 22 February (UNEP/GCSS.XI/INF/5). It should be noted that the Global Major Groups and Stakeholders Forum was formerly known as the Global Civil Society Forum. The simultaneous extraordinary meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions will also precede the session, being held on Monday and Tuesday, 22 and 23 February, with a decision-making segment in the early morning of Wednesday, 24 February. - 22. Special events will be held daily during the lunch break on matters of relevance to the Council/Forum's deliberations. In addition, several parallel events and social functions will be organized. Delegates are encouraged to participate in these events.
- 23. Several environment-focused exhibitions will be mounted during the session.
- 24. The provisional timetable of meetings and events, including information on relevant events and functions can be found in the annex to the present document, and will also be made available in the daily journal issued during the session, while the list of all official documents submitted to the Council/Forum is available as document UNEP/GCSS.XI/INF/1. #### **Item 3: Credentials of representatives**

25. In accordance with rule 17 of the rules of procedure, the credentials of representatives at the eleventh special session will be examined by the Bureau, which will report thereon to the Council/Forum. It should be noted that, under rule 16, each member of the Governing Council is to be represented by one accredited representative, who may be accompanied by alternate representatives and advisers. The credentials of the representatives, which should be issued by a head of State or

Government, or by a minister for foreign affairs, shall be submitted to the Executive Director before the first meeting of the session of the Council/Forum.
