Summary

The Executive Director has the honour to present, in the annex to the present note, information on the status of new and existing conventions and protocols in the field of the environment, covering the period 1 February 2009–31 January 2011. The annex has been issued without formal editing.

Annex

Status of conventions and protocols in the field of the environment

1. The present document is submitted in response to Governing Council decision 24 (III) of 30 April 1975, which requested the Executive Director to inform the Council at each session of the status of new and existing conventions in the field of the environment, and to General Assembly resolution 3436 (XXX) of 9 December 1975, which requested the Governing Council to keep the General Assembly informed of any new conventions in that field and of the status of existing conventions. It covers the period from 1 February 2009 to 31 January 2011. It is based on the information received by the UNEP secretariat from depositary Governments and organizations.

A. Conventions and protocols that have entered into force during the reporting period

- 2. The secretariat has been informed that the following instruments entered into force during the reporting period:
- (a) Protocol on Pollutant Release and Transfer Registers to the Convention on Access to Information, Public Participation in Decision-Making and Access to Justice in Environmental Matters, adopted in Kiev on 21 May 2003, entered into force on 8 October 2009;
- (b) Protocol on Conservation and Sustainable Use of Biological and Landscape Diversity to the Framework Convention on the Protection and Sustainable Development of the Carpathians, adopted in Kiev on 22 May 2003, entered into force on 28 April 2010;
- (c) Protocol on Strategic Environmental Assessment to the Convention on Environmental Impact Assessment in a Transboundary Context, adopted in Kiev on 21 May 2003, entered into force on 11 July 2010;
- (d) Agreement on the Central Asian and Caucasus Regional Fisheries and Aquaculture Commission, approved by the FAO Council at its Hundred and Thirty Seventh Session in October 2009, entered into force on 3 December 2010.
