

# **Meeting of Major Groups and Stakeholders back to back with the meeting of the Bureaus of the United Nations Environment Assembly and the Committee of Permanent Representatives**

**March 21 - 22, 2018, Nairobi, Kenya**

## **Agenda**

### **Background**

The **third session** of the United Nations Environment Assembly took place in December 2017, under the over-arching theme “Towards a pollution-free planet”. It brought together an unprecedented number of governments, international organizations, Major Groups, private sector representatives, scientists, media and individuals, and adopted a Ministerial Declaration and 11 specific resolutions, through which member states agreed to address pollution to air, land and soil, freshwater, and oceans. The resolutions and decisions called for accelerated action and strengthened partnerships to, for example: combat the spread of marine plastic litter and microplastics; eliminate exposure to lead paint and promote sound management of used lead-acid batteries; improve air quality globally; address water pollution; manage soil pollution; and control pollution in areas affected by terrorist operations and armed conflict.

The **fourth session** of the UN Environment Assembly will take place from 11-15 March 2019, in Nairobi, Kenya. The theme of the 2019 Assembly and key elements of the overall preparatory process will be discussed during a joint 2-day meeting of the Bureau of the Committee of Permanent Representatives to UN Environment and the Bureau of the Assembly on March 22 – 23 in Nairobi, Kenya. To date, the following themes have been proposed for the 2019 Assembly:

- Sustainable Consumption and Production
- Food and Nature/Biodiversity
- Innovation for the Environment

On March 21, about 15 representatives of Major Groups and Stakeholders are invited by UN Environment to come to Nairobi to discuss the follow up to the 2017 Assembly and to prepare their input to the meeting of the Bureaus. A joint consultative meeting between Major Groups and the Assembly is planned to take place in the morning of March 22.

### **Objectives of the Meeting of Major Groups**

The meeting of Major Groups and Stakeholders will have the following overarching objectives:

- To take stock of the outcomes of the third UN Environment Assembly, discuss lessons learned and propose options for the way forward to promote implementation of the declaration and resolutions in relation to the theme “pollution”

- To develop a vision for Major Groups and Stakeholders for the fourth UN Environment Assembly, including:
  - Identification of an overarching theme of the fourth Assembly, including topics that should be addressed in addition to the main theme
  - Develop a roadmap for stakeholder engagement in the preparatory process for the 2019 Assembly
  - Identify opportunities and challenges towards ensuring an effective and meaningful engagement of stakeholders at the 4<sup>th</sup> Assembly, including through the Multi-Stakeholder Dialogue and the Global Major Groups and Stakeholders Forum
- To share the vision with Member States and engage in an exchange of views.

### **Expected Results**

It is expected that the meeting will result in:

- Concrete Stakeholder recommendations regarding the way forward on “Pollution”
- A Stakeholder recommendation regarding the theme of the 2019 Environment Assembly
- Proposals on how to strengthen the engagement of Major Groups and Stakeholders at the 4<sup>th</sup> Assembly, including during the preparatory process and at the Global Major Groups and Stakeholders Forum
- A proposal for a specific theme for the Multi-Stakeholder Dialogue.

Participants are encouraged develop short papers well in advance of the meeting that may be shared with member states and Major Groups.
