Decision 2/2: Parties' assessed contributions to the revolving fund for emergency situations

The Conference of the Parties,

Taking into account the Financial Rules for the administration of the Bamako Convention on the Ban of the Import into Africa and the Control of Transboundary Movement and Management of Hazardous Wastes within Africa adopted by the Conference of the Parties in its decision 1/8,

Noting the establishment by the Conference of the Parties in its decision 1/8 of a revolving fund for assistance in case of emergency situations, in accordance with paragraph 3 of article 14 of the Bamako Convention,

Also noting the adoption by the Conference of the Parties in its decision 1/8 of the scale of assessments for the biennium 2018–2019,

Bearing in mind the need to develop a new scale of assessments reflecting balanced contributions among parties,

- 1. Decides to appropriate \$100,000 to the revolving fund for assistance in case of emergency situations in replacement of the appropriation made by decision 1/9 adopted by the Conference of the Parties at its first meeting,
- 2. *Adopts* the parties' assessed contributions to the revolving fund for assistance in case of emergency situations set out in the annex to the present decision;
- 3. Requests the secretariat to develop within six months of the adoption of the present decision a new scale of assessments reflecting balanced contributions among the parties, to communicate the new proposed scale to the parties for their comments and inputs, and to submit the new scale to the Conference of the Parties for its consideration at its third meeting;
- 4. *Requests* States parties to pay their contributions in full within 30 days of the receipt of the communication from the Executive Secretary requesting the payment of contributions.
