Decision 2/8: Establishing a list of hazardous substances to be considered hazardous waste under article 2, paragraph 1 (d)

The Conference of the Parties,

Recalling paragraph 1 (d) of article 2 of the Bamako Convention on the Ban of the Import into Africa and the Control of Transboundary Movement and Management of Hazardous Wastes within Africa, which considers hazardous substances that have been banned, cancelled or refused registration by government regulatory action, or voluntarily withdrawn from registration in the country of manufacture, for human health or environmental reasons to be “hazardous wastes”,

Recalling also its decision 1/22, in which the Conference of the Parties at its first meeting requested the secretariat, in cooperation with the Secretariat of the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade, to produce a list of substances as described in paragraph 1 (d) of article 2 in order to establish a new annex VI to the Bamako Convention to be approved by the Conference of the Parties at its second meeting,

Recognizing the need to establish a dynamic list of substances as described in paragraph 1 (d) of article 2 in order to complete a new annex containing such substances and to provide the parties with a complete definition of hazardous wastes as defined by the Bamako Convention in order to increase the implementation and enforcement of the Bamako Convention,

Requests the parties to review the list of new proposed substances set out in the annex to the present decision and to submit their comments, inputs and observations to the secretariat, within two months of the adoption of the present decision on 1 February 2018, for review and compilation by the secretariat, which in turn will share with the parties the proposed list of substances for final review and adoption by the Conference of Parties at its forthcoming extraordinary meeting to be held in Khartoum in February 2019.

Annex to decision 2/8

List of hazardous substances that have been banned, cancelled or refused registration by government regulatory action, or voluntarily withdrawn from registration in the country of manufacture, for human health or environmental reasons (art. 2, para. 1 (d), of the Bamako Convention)

Note: This is not an exhaustive list of substances that have been banned, cancelled, refused registration or voluntarily withdrawn. The present document should be considered as a living document. The list is mostly derived from pesticide regulations in various countries. There are other industrial chemicals and chemical products that have been banned by regulations. For example, more research will be needed on fuels banned from use by the European Union (see Council Directive 2009/30/EC amending Directive 98/70/EC and Directive 1999/32/EC and repealing Directive 93/12/EEC [2009] OJ L 140/88, Art 8(a), para. 1, Annex I and Annex II, available at <http://eurlex.europa.eu/LexUriServ/LexUriServ.do?uri=OJ:L:2009:140:0088:0113:EN:PDF>).

There are other products that are similarly defined by what is allowed rather than by what is banned, e.g., lead content in ceramics. It is likely that some additional work will be required to examine such products after the second meeting of the Conference of the Parties.
