Introduction

- 1. The 20th Ordinary Meeting (COP20, Tirana, Albania, December 2017) of the Contracting Parties mandated the Secretariat (Decision IG.23/14) to develop in line with Article 15 of the LBS Protocol of the Barcelona Convention, the main elements of six Pollution Reduction Regional Plans (herein after referred to as the Regional Plans) as indicated below:
 - Municipal Wastewater Treatment;
 - o Sewage Sludge Management;
 - o Agriculture Nutrients Management;
 - o Aquaculture Nutrients Management;
 - o Urban Storm Water Management; and
 - o Marine Litter
- 2. The proposed main elements of the six regional Plans will be submitted to the MED POL Focal Points at their Meeting in 2019 for their review and guidance on the next steps on their finalization for further consideration, as appropriate, by the MAP Focal Points Meeting and COP 21, December 2019, Naples, Italy.
- 3. The objective of the present Regional Expert Meeting is to review the Secretariat's proposal on the main elements of the Regional Plans; the approach for their identification; including proposed timeline and provide guidance for their finalization and next steps.
- 4. The following annotations to the Provisional Agenda were prepared by the Secretariat to assist the Meeting in its deliberations.

- 3. Subject to Rule 20 of the rules of procedure mentioned at para. 2(a), the Meeting will elect a President, three Vice Presidents and a Rapporteur from among the representatives of the Contracting Parties.

- c) Adoption of the Provisional Agenda
- 4. Subject to Rule 14 of the rules of procedure mentioned at para. 2(a), the proposed agenda appearing in document UNEP/MED WG.454/1/Rev.1 and annotated in the present document will be reviewed and proposed for adoption by the Meeting including the timetable contained in the Annex to the present document.
 - d) Organization of Work
- 5. The discussions are proposed to be held in plenary sessions.
- 6. Simultaneous interpretation in English and French will be provided during the Meeting. Documentation will be in English and French. As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session. Sessions are scheduled every day from 09:30-12:30 and 14:30-17:30.
- 7. It is expected that the Meeting will address all items of the Agenda during the two-day meeting. It is envisaged to close the meeting at 17:30 on 21 November 2018 after adopting its Conclusions and Recommendations.
