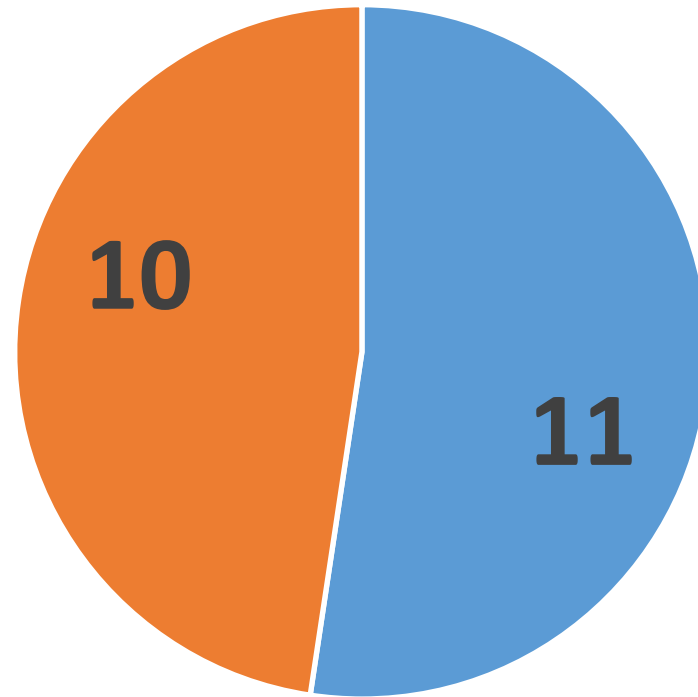

Regional Scope of Current and Planned Projects

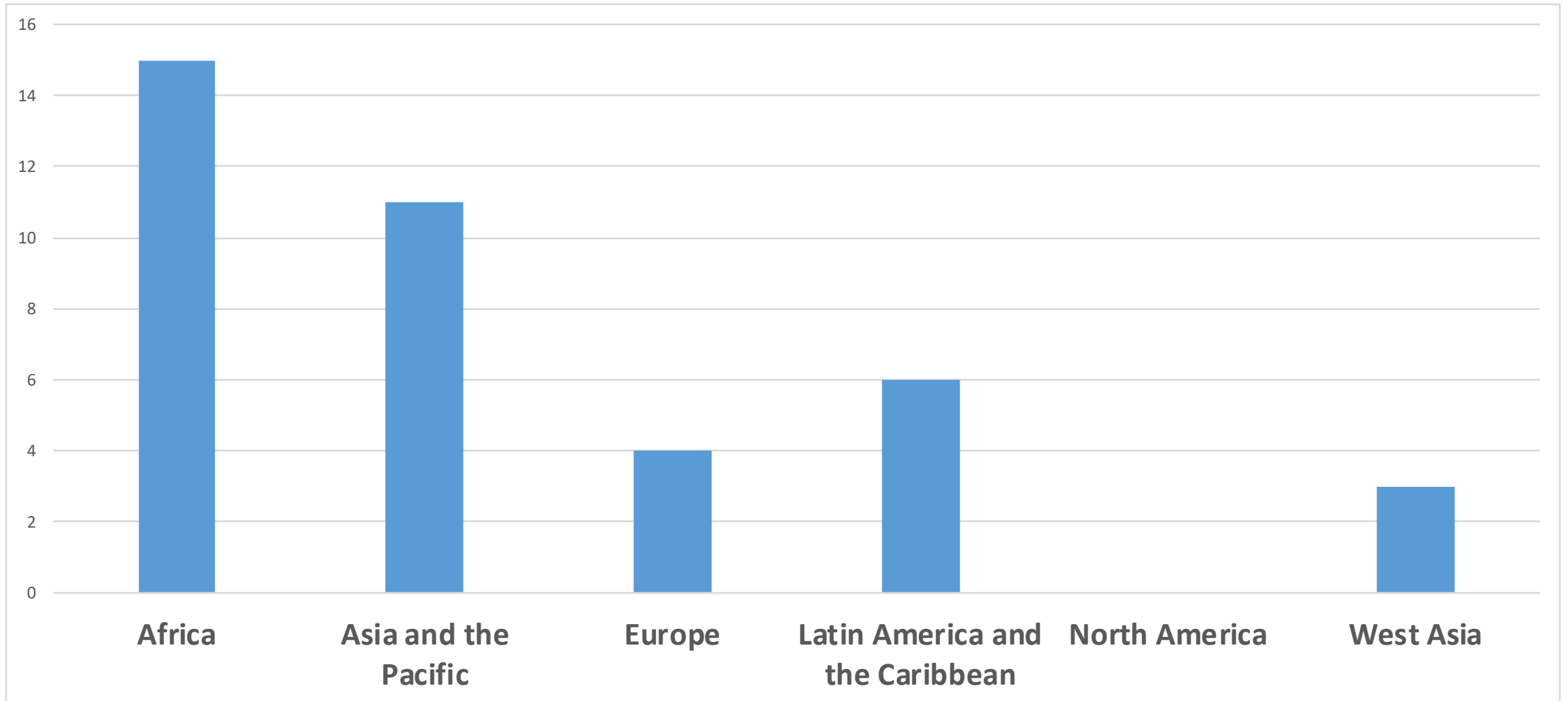
(As of October 2018)
