Response to EU questions on South-South Cooperation Presentation at CPR of 8th November 2018

Dear Excellencies,

The Secretariat is pleased to present the following responses to questions that were received on aspects of the South-South Cooperation work during the CPR briefing held on 8th November 2018.

1. Question on discrepancy between the number of Environment Fund projects mentioned in the briefing note and stated on the presentation slides (7), and the number of Environment Fund projects included in the Annex 4 List of South-South and Triangular Cooperation Projects (1):

Several projects are funded through the Environment Fund. A **Partnership Development and South-South Cooperation Fund** was established in 2015 to support projects that were exclusively focused on development of new partnerships or South-South Cooperation as the primary mechanism for implementation. Seven projects received funding. As of November 2018, six of the seven projects are completed while the project "Delivering Sustainable Development and Enabling the Transition to Greener Economies through Sustainable Public Procurement" remains under implementation. The briefing note as well as the presentation which were provided for the CPR meeting, referred to the overall number of projects which received funding, whereas the annex only included projects currently under implementation, hence the discrepancy. This has since been rectified to ensure that all materials show the same information.

2. Development of a South-South and Triangular Cooperation (SSTC) Strategy

As mentioned during the briefing, the South-South Cooperation Unit will, over the coming months, be working on the development of a South-South and Triangular Cooperation Strategy for the organization. A road map for the development of the strategy will be developed during a workshop on SSTC that is taking place during 10-11 December. The workshop will bring together staff involved in SSTC from various offices and divisions. Consultations with Member States will take place at this time, and subsequently.

3. Extent to which the South-South Cooperation Policy Guidance from 2011 informs the implementation of the Programme of Work.

From 2011 to date, UN Environment Programme has been implementing projects relating to South-South and Triangular Cooperation largely in accordance with "Integrating South-South Cooperation in the UNEP Programmes of Work: Policy Guidance" (Policy Guidance). The following table summarises the implementation of Policy Guidance by UN Environment Programme in recent years.
