Introduction

1. The importance of temporal and geographical scales of monitoring is recognized in the Integrated Monitoring and Assessment Programme of the Mediterranean Sea and Coast and Related Assessment Criteria (Decision IG.22/7, here in after referred to as IMAP Decision, as a transversal issue for monitoring.

2. The SPI Inception Workshop held on 15th and 16th December 2015., building on this principle, highlighted the specific need for the development of guidelines to define such scales of monitoring for each of the IMAP common indicators and scales of reporting and assessment at regional level.

3. The key aim of the inception workshop was to launch the activity dedicated to the Science-Policy strengthening within the frame of the EcApMedII project.

4. In this context, the Science-Policy Interface Meeting (SPI Workshop) is organized to provide the ground for an initial discussion between scientists and policy makers on the definition of temporal and geographical scales of monitoring, reporting and assessment to further develop the implementation of the IMAP

5. Its ultimate objective is to enable exchange of views between scientists and policy makers, and provide recommendations for the definition of relevant geographical and temporal scales. It is also foreseen exchange information on best practices by the Contracting Parties or other regional partners.

6. The discussion on the scale of assessment and reporting is expected to support the review of the draft QSR 2017 assessment fact sheets prepared by the Secretariat under the guidance and or with contribution from CorMon held respectively in October, 2016 and March 2017.

7. The workshop will be held in Nice, in Aston La Scala Hotel, on 27th - 28th April 2017.

10. The Provisional Agenda annotated in the present document will be reviewed, amended as necessary, and adopted by the Meeting. Simultaneous translation in English and French will be provided during the Meeting.

Plan Bleu will introduce the temporal and geographical scales of monitoring, reporting and assessment to further develop the implementation of the map integrated monitoring and assessment programme (IMAP) presented in the working document (UNEP(DEPI)/MED WG.438/3). The Mediterranean countries have to adapt due to new requirements in IMAP (Common and candidate indicators) in order to achieve GES.

12. The presentation will be followed by a discussion with the audience regarding the fact that developing monitoring, reporting and assessment which is a cumulative and adaptive process. So it's important to define the relevant spatial & temporal scales of monitoring for IMAP's indicators.

Agenda item 3.Best Practices on Assessment and Reporting Scales (Practices Of
Regional Seas and of Contracting Parties)

13. A series of presentations will be delivered on: SPI good practices and examples of the definition of relevant geographical and temporal scales of monitoring to marine litter, marine biodiversity, coast and hydrography at national levels and related to the corresponding MAP/EcAP Ecological objectives and IMAP indicators.

14. The presentations will present concrete and best examples on monitoring for each Ecological Objective and indicators and will show that Secretariat requested countries to develop national monitoring programmes regarding common indicators. They will show that it exists different scales for action and management. They will highlight the fact that monitoring allows to develop programmes of measures to achieve GES. Following these presentations participants will undertake discussions and provide further recommendations on how to define relevant scales of monitoring for IMAP implementation.
