Introduction

- 1. The main objectives of the Meeting of the Mediterranean Action Plan (MAP) Focal Points are: to review the progress achieved during the 2018-2019 biennium in the implementation of the Programme of Work and of the activities approved by the 20th Meeting of the Contracting Parties (COP 20) (Tirana, Albania, 17-20 December 2017); and to approve a number of Draft Decisions, including the proposed biannual Programme of Work (PoW) and Budget 2019-2020, prepared by the Secretariat for submission to the 21st Meeting of the Contracting Parties (COP 21) (Napoli, Italy, 2-5 December 2019), aiming at strengthening the implementation of the Barcelona Convention and its Protocols.
- 2. The following proposed Provisional Annotated Agenda has been prepared by the Secretariat to assist the Meeting in its deliberations.

Agenda Item 1: Opening of the Meeting

3. The Meeting will be opened at 09.30 on 10 September 2019 by the President of the Bureau, Ms. Klodiana Marika and the Coordinator of the United Nations Environment Programme/Mediterranean Action Plan (UNEP/MAP)—Barcelona Convention, Mr. Gaetano Leone.

2.1 Rules of Procedure

- 5. Subject to Rule 20 of the Rules of Procedure mentioned at para. 2(a), the Meeting of the MAP Focal Points will elect a President, four Vice Presidents and a Rapporteur from among the representatives of the Contracting Parties.

- 6. Subject to Rule 14 of the Rules of Procedure mentioned at para. 2(a), the proposed agenda appearing in document UNEP/MED WG.468/1 and annotated in the present document will be proposed for adoption by the Meeting. The Meeting will review and adopt the agenda and the proposed timetable contained in the Annex to the present document, including as appropriate any other issues suggested to be addressed under the item "Any Other Business" of the provisional agenda.

2.4 Organization of Work

- 7. The discussions will be held in plenary sessions and as appropriate in working groups to address specific agenda items, subject to decision by the Meeting during the adoption of the provisional agenda.
- 8. Simultaneous interpretation in English and French will be available for the plenary sessions. Documentation will be in English and French. As per practice, pre-session documentation will not be distributed on paper. Participants are encouraged to download the documentation on their computers in advance of the session.

- 9. Sessions are scheduled every day from 09:30-12:30 and 14:30-17:30. The morning of the last day of the Meeting will be allocated for the preparation of the Report of the Meeting and the afternoon session will take place between 14:30 and 17:30.
- 10. It is expected that the MAP Focal Points will address all items of the Agenda during their four-day Meeting. It is envisaged to close the Meeting at 17:30 on 13 September 2019 after adopting its Draft Report.

- The Coordinator will present the document "Progress Report on Activities Carried Out during 11. the 2018-2019 Biennium" (UNEP/MED WG.468/3) outlining the work done as well as the main achievements and challenges encountered in the implementation of the Barcelona Convention and its Protocols since COP 20. The Meeting will also consider the "Overall Findings from the General Status of the Progress in the Implementation of the Barcelona Convention and its Protocols: Analysis of the Information Mentioned in the National Reports for the 2016-2017 Biennium" (UNEP/MED WG.468/20).
- 12. The Meeting is expected to review the progress achieved on the implementation of the PoW and Budget adopted by COP 20 and discuss opportunities, challenges, and lessons learned.

Agenda Item 5: Specific Matters for Consideration and Action by the Meeting, including Draft Decisions

- 13. Under this agenda item the Meeting will consider a number of Draft Decisions addressing specific issues related to the implementation of the Barcelona Convention and its Protocols as well as strategic and programmatic documents. Sub-items have been organized following the structure of the UNEP/MAP Mid-Term Strategy 2016-2021 (MTS), encompassing the overarching, core and crosscutting themes of the MTS.
- 14. The Secretariat has prepared for each specific Draft Decision, working documents containing a Note by the Secretariat, the Draft Decision and, as applicable, Annexes to the Draft Decision. The

brief introductory Note by the Secretariat contains details on the relevant mandate, background and process, objectives and substantive highlights, and links to the proposed 2020-2021 PoW outputs and budget, as appropriate.
