#### Introduction

1. The third meeting of the Contracting Parties to the Convention for Cooperation in the Protection and Development of the Marine and Coastal Environment of the West and Central African Region was convened by the Executive Director of the United Nations Environment Programme (UNEP), after consultation with the Chairman of the Steering Committee and of the Conference of Contracting Parties and in accordance with the resolution on institutional arrangements adopted by the Conference of Plenipotentiaries on Cooperation in the Protection and Development of the Marine and Coastal Environment of the West and Central African Region, held at Abidjan from 16 to 23 March 1981 (UNEP/IG.22/7). The meeting was held on 26 November 1993 in Addis Ababa, Ethiopia, in the offices of the United Nations Economic Commission for Africa (ECA).

2. The following Contracting Parties, as recorded in the report presented by the Depositary of the Convention (Côte d'Ivoire) at the seventh meeting of the Steering Committee on 25 November 1993, were all invited to attend the meeting: Cameroon, Congo, Côte d'Ivoire, Gabon, Ghana, Guinea, Nigeria, Senegal and Togo. The other States of the West and Central African region, as defined in article 1 of the Convention, were invited to participate in the meeting as observers. The international, intergovernmental and regional organizations concerned with the Action Plan for the West and Central African Region were also invited to the meeting as observers.

Representatives of the following Contracting Parties attended the meeting: Cameroon, Congo,
Côte d'Ivoire, Gabon, Ghana, Guinea, Nigeria and Senegal.

4. Representatives of Angola, Benin, Cape Verde, the Gambia, Mauritania, Namibia, Sao Tome and Principe, Sierra Leone and Zaire participated in the meeting as observers.

5. Representatives of the following international organizations attended the meeting as observers: the Food and Agriculture Organization of the United Nations (FAO), the Organization of African Unity (OAU) and the World Bank.

6. A full list of participants is contained in annex I to the present report.

Agenda item 1: Opening of the meeting

7. The meeting was opened on 26 November 1993 at 9.30 a.m. by Mr. Abdoulaye Bathily, Minister of Environment and Nature Protection of Senegal, Chairman of the meeting of the Contracting Parties, who welcomed the participants and thanked the Executive Director of UNEP for having convened the third meeting of the Contracting Parties as well as the Economic Commission for Africa for hosting the meeting.

## Agenda item 2: Organization of the meeting

### Agenda item 2.1: Rules of procedure

 It was decided that the rules of procedure for meetings and conferences of the Contracting Parties, adopted by the first meeting of the Contracting Parties, held in Abidjan from 18 to
20 April 1985 (UNEP/IG.59/6, annex VI), would apply to the conduct of the meeting.

#### Agenda item 2.2: Election of the Bureau

9. The meeting decided that the session should be chaired by Mr. Abdoulaye Bathily, with the election of a new Bureau under agenda item 8.

#### Agenda item 2.3: Organization of work

10. It was decided that the meeting would be held in plenary sessions only.

11. The meeting was conducted in English and in French. Simultaneous interpretation was provided in those languages. All the documentation for the meeting was available in English and French, with the exception of the information documents.

## Agenda item 2.4: Credentials

12. The Bureau examined the credentials of the delegations attending the session and found them to be in order.

Agenda item 3: Adoption of the agenda

# 13. The Contracting Parties adopted the agenda, which is contained in annex II to the present report.

Agenda item 4: Report of the Executive Director of UNEP

14. Since the report of the Executive Director of UNEP (UNEP(OCA)/WACAF IG.5/4/Rev.1) had already been presented to and considered by the seventh meeting of the Steering Committee, held in Addis Ababa on 25 November 1993, the Chairman suggested that there was no need to reintroduce it at the current meeting. The suggestion was adopted by the Contracting Parties.

15. A full list of documents submitted to the meeting is contained in annex III to this report.

# Agenda Item 5: Report of the Chairman of the Steering Committee

16. Since the report of the Chairman of the Steering Committee had already been presented to the Steering Committee, the Chairman suggested to the Contracting Parties that they should move on to the next item. The suggestion was adopted by the meeting.

## Agenda item 6: Report of the Depositary of the Convention

17. Since the report of the Depositary of the Convention had already been presented to the seventh meeting of the Steering Committee, the Chairman suggested to the Contracting Parties that there was no need to reintroduce it. The suggestion was adopted by the meeting.

## Agenda item 7: Consideration of the report of the Steering Committee

Mr. Abdoulaye Bathily, Chairman of the Steering Committee, introduced the report of the seventh meeting of the Steering Committee (UNEP(OCA)/WACAF IG.4/3), held on
November 1993, including its recommendations to the third meeting of the Contracting Parties.
The report is contained in annex V to the present report.

19. After considering the reports and recommendations of the Executive Director (UNEP(OCA)/WACAF IG.5/4/Rev.1), the Chairman of the Steering Committee (UNEP(OCA)/WACAF IG.5/3) and the seventh meeting of the Steering Committee (UNEP(OCA)/WACAF IG.4/3), the Conference took note of progress in the implementation of the Action Plan and the Convention as well as of the financial arrangements to support the Action Plan and of the status of the Trust Fund, in particular, and <u>decided</u>:

(a) To endorse the evaluation of the past achievements and shortcomings in the implementation of the Action Plan contained in the report of the Executive Director of UNEP (UNEP(OCA)/WACAF IG.5/4/Rev.1);

(b) To urge all States that had not yet done so to ratify or accede to the Abidjan Convention and its Protocol and to deposit their instruments of ratification or accession with the Depositary of the Convention (Côte d'Ivoire);

(c) To cancel the outstanding pledged contributions of each of the States of the West and Central African region;

(d) To extend the Trust Fund until 31 December 1995;

(e) To grant Namibia the opportunity of contributing to the Trust Fund;

(f) To request UNEP to establish financial arrangements which would enable States to contribute to the Trust Fund in their national currency;

(g) To request States in the region to contribute to the Trust Fund on a voluntary basis during the period of transition 1994-1995;

(h) To request the Executive Director of UNEP to establish new modalities for the assessment of contributions by States, which would take into consideration their economic and financial situation and, for those States which had contributed in the past, the available balance of the Trust Fund as at 31 December 1993:

(i) To request the Executive Director of UNEP to take all necessary action, in particular

with the competent services of United Nations Headquarters in New York, for the signing of the headquarters agreement for the Regional Coordinating Unit and to consider any arrangement which would enable this Unit to operate at UNEP headquarters at Nairobi from the beginning of 1994 for  $\equiv$  transitional period of not more than one year;

(j) To approve the evaluation of the past achievements and shortcomings in the implementation of the Action Plan, contained in the report of the Executive Director;

(k) To approve the orientation of the WACAF Action Plan described in paragraphs 82-84 of the Executive Director's report;

(I) To approve the recommendations regarding the Action Plan in the medium and short term contained in paragraphs 85-106 of the report of the Executive Director and in the paragraphs relating to agenda item 5.6 of the seventh meeting of the Steering Committee;

(m) To request the Executive Director of UNEP to carry out actions in accordance with those recommendations in the framework of its oceans and coastal areas programmes for the period 1994-1995, in accordance with the priorities for the region as set forth under agenda item 5.1 of the seventh meeting of the Steering Committee;

(n) To prepare for the eighth meeting of the Steering Committee in 1994 and the ninth meeting of the Steering Committee and the fourth meeting of the Contracting Parties in 1995;

(o) To contribute to the activities relating to seas and small island ecosystems agreed upon by the African Ministerial Conference on the Environment (AMCEN);

(p) To request the Bureau of the Steering Committee, with the assistance of the secretariat, to draw up detailed activity plans and corresponding budgets for the period leading up to the eighth meeting of the Steering Committee, in 1994.

## Agenda item 8: Election of members of the Bureau and of the Steering Committee

20. In accordance with rule 21 of the rules of procedure for meetings and conferences of Contracting Parties, the meeting elected the following Bureau:

23. The Chairman thanked Mr. Abdoulaye Bathily for his words of encouragement and, on behalf of all the participants at the meeting, thanked the ministers of environment of Senegal who, in turn, had presided over the Action Plan for West and Central Africa for their dedication to the region's future.

### Agenda item 9: Other business

24. Several States registered their dissatisfaction with the physical organization of meetings of the Steering Committee and the Contracting Parties and the lack of time that the participants had had to discuss their environmental problems in greater depth.

#### Agenda item 10: Adoption of the report

25. The draft report was presented to the meeting by the Rapporteurs and it was adopted with amendments as reflected in the present document.

26. The secretariat was requested to finalize the report, making necessary editorial changes, and to distribute it as appropriate.

#### Agenda item 11: Closure of the meeting

27. The Chairman declared the meeting closed at 11 a.m. on 26 November.


