## II. Challenges with the implementation of the Regional Seas Strategic Directions 2017 – 2020

The RSSD were considered in and supported the development COBSEA Strategic Directions 2018-2022, and its priorities are well reflected there. But the extent to which it actually influenced/steered the COBSEA Strategic Directions 2018-2022 is debatable. The RSSD 2017-2020 are somewhat innocuous. The 'nature' of the RSSD as a strategic document (level, focus, interrelationship with a multitude of other strategic and planning frameworks etc) may need some further consideration.

While good progress has been made, capacity limitations (financial, human resources) have restricted COBSEA's delivery of some elements in RSSD that are incorporated in the COBSEA Strategic Directions 2018-2022.



### III. Lessons learnt (2017 – up to date)

Engagement with and input from other RS has been very meaningful for COBSEA. e.g. information sharing and activity alignment with and participation in meetings of neighbouring RS has been programmatically as well as politically meaningful Also, input and experiences shared by other RS in developing COBSEA's institutional framework has been very useful in 'revitalizing' COBSEA. This is one of the more important aspects of RS as a collective.
