Draft Roadmap for GFCM-INFO/RAC cooperation in the framework of the MoU between UNEP/MAP and GFCM-FAO

Introduction

As stated in the Decision IG.22/7: *"it is an absolute necessity for UNEP/MAP to strengthen its cooperation with the relevant regional bodies, especially in relation to:*

- **EO1**, both with the **General Fisheries Commission for the Mediterranean (GFCM)** for commercial species of fish and shellfish and the Secretariat of the Agreement on the Conservation of Cetaceans of the Black Sea, Mediterranean Sea and contiguous Atlantic area (ACCOBAMS), noting that the ACCOBAMS Survey Initiative, to be undertaken during 2016-2019, will provide important inputs (in terms of monitoring methodologies, capacity building and reliable data on abundance and distribution of cetaceans);
- **EO3**, with the **GFCM**, noting that the EO3 related common indicators will be further developed and assessed by GFCM (with assessment results provided to UNEP/MAP in order to undertake the 2017 and following integrated assessments)"

In the context of the EcAp MED II project and in the framework of the MoU between GFCM and UNEP/MAP, INFO/RAC has started the building of a **specific partnership with GFCM** to ensure that relevant data collection can be shared within the EcAp process.

INFO/RAC has developed the IMAP **Pilot Info System (PIS)** and is now engaged in its completion and finalization (**IMAP Info System**) for the 27 IMAP Common Indicators, including those related to the Ecological Objective 3.

The present roadmap has been developed to clarify the next steps for the implementation and integration of the EO3 (and EO1) Common Indicators in the future IMAP Info System.
