

Implementation of paragraph 88: Mandate

UNEA Decision 4/2, paragraph 14:

- Executive Director to submit an action plan for the implementation of subparagraphs (a)–(h) of paragraph 88 of the outcome document for consideration by UNEA 5
- invites the Director-General of UNON to contribute to the development of the plan in respect of the implementation of subparagraph (g) concerning the headquarters functions of the UNEP in Nairobi





8 Subparagraphs

- (a) Establish universal membership;
- (b) Have secure, stable, adequate and increased financial resources;
- (c) Enhance the voice and coordination function;
- (d) Promote a strong science-policy interface;
- (e) Disseminate and share evidence-based environmental information, and raise public awareness;
- (f) Provide capacity-building to countries, as well as support, and facilitate access to technology;
- (g) Progressively consolidate headquarters functions in Nairobi, as well as strengthen its regional presence;

(*h*) Ensure the active participation of all relevant stakeholders.



Implementation of Paragraph 88: Revised Draft Roadmap

Dates	Elements
Nov 2019	Initial consultation with the UN Office at Nairobi
Dec 2019	Secretariat report: What has been achieved so far?
TBD	Possible thematic consultations on the subparagraphs with member States and stakeholders
June 2020	Secretariat report: What more needs to be done?
Fall 2020	Submission of a first draft action plan for discussion at the 7 th annual subcommittee meeting
Nov 2020	Submission of final draft action plan for consideration at UNEA-5

<u>February 2013 – 1st universal session of the Governing Council</u> Decision 27/2, "Implementation of paragraph 88 of the outcome document of the UN Conference on Sustainable Development"

June 2014 – 1st session of UNEA

Report on the implementation of UNEA decision 27/2, particularly on:

- UNEP's voice and coordination
- Science-policy interface
- Consolidation of headquarters functions
- Stakeholder engagement

December 2017 – 3rd session of UNEA

Resolution 3/11 "Implementation of paragraph 88 (a)-(h) of the outcome document of the UN Conference on Sustainable Development, entitled "The future we want"".

<u>March 2019 – 4th session of UNEA</u> Report on the implementation of resolution 3/11



Looking forward: Possible thematic consultations

- Seeking guidance from CPR on how/when to organize them
- Consultations aim to identify what more needs to be done – jointly by member States, stakeholders and the secretariat – to implement para 88, with a view to informing the action plan development
- Outcomes of the consultations will inform a secretariat report "What more needs to be done", which will then feed into the "action plan" for submission to UNEA-5.
