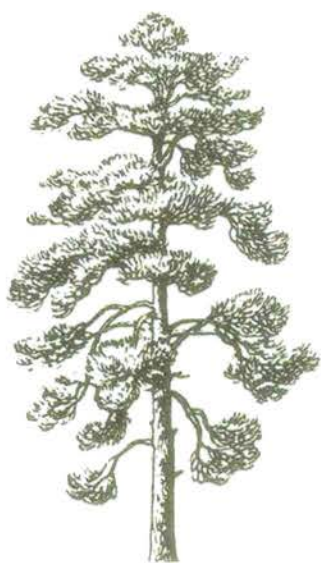

## USER'S GUIDE

This handbook serves to pull together all of the applicable Governing Council decisions and resolutions concerning forests, woodlands, desertification and related areas for the past fourteen sessions, including the Session of a Special Character(1982).

For reference purposes, the handbook has been divided into three sections: a subject index of the decisions and resolutions, followed by the applicable text, and an appendix comprised of tables reflecting apportionment of the Environment Fund for all sessions. The subject index has been arranged into four subsections, as shown in the table of contents. Within each subsection, all relevant decisions and resolutions appear chronologically. The page numbers following each listing refer to the pertinent area of text as applicable to that subsection only. The Environment Fund tables found in the appendix are also presented in chronological order, and have been included to provide the reader with an historical overview.

All indexing terminology has been used within UNBIS (United Nations Bibliographic Information System) guidelines following the format contained in the UNBIS Thesaurus (ST/LIB/40). For example, "UNEP/GC/DEC/7/6" translates into:

"UNEP Governing Council decision number six from the seventh session."

"RES" refers to the resolutions adopted at the Session of a Special Character (1982). The titles and subtitles of all decisions and resolutions have been taken directly from the original text. All document symbols from the report of the Governing Council appear after each listing, followed by the corresponding General Assembly official record number.

The index subsections entitled "Environmental Education and Training", and "Environmental Policy, Protection and Management" have been included solely in the instances where a relationship to forestry and desertification could be shown, when examined within a broad scale. For streamlining purposes, some editing of the text has been employed so that the reader can refer directly to the applicable body of the decisions and resolutions themselves. For verbatim text, one can refer to the original documents.

Report of the Environment Co-ordination Board

The Governing Council of the United Nations Environment Programme

... 1. Reiterates that, in accordance with General Assembly resolution 2997 (XXVII) of 15 December 1972 and the Action Plan of the United Nations Conference on the Human Environment, the general policy objectives of the United Nations Environment Programme shall be:

I. GENERAL POLICY OBJECTIVES

(a) To provide, through interdisciplinary study of natural and man-made ecological systems, improved knowledge for an integrated and rational management of resources of the biosphere, and for safeguarding human well-being as well as ecosystems;

(b) To encourage and support an integrated approach to the planning and management of development, including that of natural resources, so as to take account of environmental consequences, to achieve maximum social, economic and environmental benefits;

(c) To assist all countries, especially developing countries, to deal with their environmental problems and to help mobilize additional financial resources for the purpose of providing the required technical assistance, education, training and free flow of information and exchange of experience, with a view to promoting the full participation of developing countries in the national and international efforts for the preservation and enhancement of the environment;

II. PARTICULAR POLICY OBJECTIVES

... 2. (e) To prevent the loss of productive soil through erosion, salination or contamination; to arrest the process of desertification and to restore the productivity of desiccated soil;

... (f) To help Governments in managing forest resources so as to meet present and future needs;...

... (l) To help Governments identify and preserve natural and cultural areas which are significant to their countries and which form part of the natural and cultural heritage of all mankind;...

... (n) To help Governments increase public awareness through better education and knowledge of environmental concerns and facilitate wide participation in and support for environmental action;

III. PROGRAMME PRIORITIES FOR ACTION BY THE UNITED NATIONS  
ENVIRONMENT PROGRAMME

Decides that the major functional tasks of the Programme consist of the identification and assessment of the major environmental problems for which "Earthwatch" will be one of the important instruments, environmental management activities and supporting measures, the most important of which are:

(a) The provision of technical assistance to Governments in evaluating their environmental needs and in planning and carrying out measures to meet them;

(b) The provision of assistance for the training of personnel who will require specialized skills in order to participate in the development and application of measures - including environmentally sound technologies - for the protection and enhancement of the environment, with particular emphasis on planning and management;

(c) The provision of financial and other forms of support to strengthen national and regional institutions which can contribute significantly to the international institutional network required for carrying out agreed measures under the programme;

(d) The provision of information and related material in support of national programmes of public information and education in the environmental field and the provision of assistance to governmental or non-governmental efforts aiming at increased availability of environmental information related to development;

... (b) To conserve and enrich the productive resources that sustain life on this planet;

(c) To understand the effect of man's interaction with other components of the biosphere;...

(i) To mount a concerted programme to help countries control the loss of productive soil through erosion, salination, desertification and laterization, and to help them in land reclamation which is ecologically compatible, with special emphasis to be laid on arresting the spread of deserts;....

... (iv) To support and encourage concerted research programmes to develop, manage and conserve ecological systems, particularly arid lands and tropical forests, special account being taken for support of initiatives by Governments in their national and regional programmes;...

... IX. PUBLIC AWARENESS OF ENVIRONMENTAL PROBLEMS

32. Invites Governments to consider, in the light of their countries' particular circumstances, the establishment or strengthening of institutions and activities designed to improve public awareness of environmental concerns;

33. Requests the Executive Director to ensure that the activities of the Environment Programme are designed to complement and support national programmes in this area;

34. Commends the actions taken by governments and the Executive Director to mark World Environment Day, recognizes it as a valuable means for increasing public awareness and invites all governments to participate in its future observance.

... (f) Research on the impact of man and climate on the process of desertification should be encouraged....

#### ...5. Conservation of nature, wildlife and genetic resources

(b) For the preservation of aquatic and terrestrial ecosystems, biomes and habitats, efforts should be made to expand the network of terrestrial and marine parks, in which studies of the relevant ecosystems should be encouraged. Emphasis should be placed on arid lands, forests, wetlands and marine areas. The Executive Director is requested, in cooperation with appropriate international organizations, to promote studies leading to concrete action facilitating the exploration, protection and conservation of nature in the humid equatorial zones....

#### ...II. FUNCTIONAL TASKS

##### Environmental assessment: Earthwatch

... (c) The Executive Director should consider moving forward, in a manner similar to his application of the Global Environmental Monitoring System and International Referral System, with the other functional aspects of Earthwatch which involve related research and evaluation, so that the interactions among these complementary functions may properly lead to environmental assessments which provide the basis for environmental management activities.

#### 2. Environmental management

Further invites the General Assembly at its thirty-first session to approve the extension of invitations to the United Nations Conference on Desertification to all States and liberation movements in accordance with its established practice, to interested specialized agencies and intergovernmental organizations indicating an interest to participate, and to those non-governmental organizations in consultative status with, the Economic and Social Council which inform the Executive Director of their interest in being represented by observers;

8. Agrees to the draft provisional agenda for the Conference, subject to 2-6 (a) being incorporated into one item entitled "Organization of the work of the Conference", and recommends that the General Assembly at its thirty-first session approve the draft provisional agenda thus modified for presentation to the Conference for adoption;

9. Approves the financial implications of the preparations for the Conference decides:

(a) To allocate from the Fund of the United Nations Environment Programme, towards the preparations for the Conference, the sum of \$1,023,500 in 1976 and \$1 million in 1977;

(b) To request the Executive Director to provide the Governing Council, at its fifth session, with a precise accounting of the allocation for 1976;

(c) To consider at its fifth session a revised estimate of the financial implications of the preparations for the Conference, on the basis of a report by the Executive Director on progress made during the period between the fourth and fifth sessions of the Governing Council, together with a detailed plan of expenditure during the year 1977;

10. Notes that the amount of \$392,500 under Fund programme activities forms part of the approved allocation for terrestrial ecosystems, their management and control for 1976-1977;

11. Urges the Executive Director, while ensuring maximum efficiency of the preparations for this very important Conference, to exert every effort to economize the expenditure from the sums allocated according to paragraph 9 (a) above.

4. Notes the goals submitted to the Governing Council by the Executive Director and the need to give them further consideration in this process;

(c) Together with other relevant intergovernmental and non-governmental organizations, to increase their efforts to close the gaps in knowledge and appropriate technology related to combating desertification, with particular emphasis on socio-cultural dimensions and the teaching of the existing and newly acquired knowledge to potential users, particularly at the level of extension agents and farmers/pastoralists;

6. Takes note with appreciation of the work of the Consultative Group for Desertification Control at its second session and of the declarations of support expressed by several participants during the session, and urges them to translate these declarations into specific commitments in the near future, requests the Executive Director to follow up the results of the work of the Group's second session with a view to ensuring proper implementation of the agreements reached and calls on the Consultative Group to intensify its efforts to assist the Executive Director in the mobilization of resources needed for the implementation of the Plan of Action to Combat Desertification;

7. Authorizes the Executive Director to continue for 1980-81 to contribute to the United Nations Sudano-Sahelian Office, after consultations with the Administrator of the United Nations Development Programme, the share contributed by the United Nations Environment Programme of the administrative and operational costs of the joint venture on the basis of the work plan to be approved by the Executive Director, within the available resources of the Environment Fund, and to submit to the Governing Council, at its ninth session, the full account of the operational expenditures for 1978-1980 and their place within the total operational expenditures of the Office related to its additional anti-desertification mandate, with a view to providing the Governing Council with a basis for considering future financing of the operational costs of the joint venture;

8. (e) Utilization of existing national universities and regional environmental education centres for the training and re-training of personnel in environmental education and management.

Environmental education and training in Latin America  
and the Caribbean

The Governing Council,

... 1. Expresses its approval of the holding and the results of the Ad hoc Meeting of Representatives of the Latin American and Caribbean Countries and Spain on Environmental Education and Training, held at Montevideo from 19 to 21 November 1980, at which it was agreed that the establishment of a network of institutions responsible for providing environmental training in Latin America and the Caribbean should be initiated shortly;

Resolution 1

The environment in 1982: retrospect  
and prospect

The Governing Council,

...I

The major achievements in the implementation of the  
Action Plan for the Human Environment

1. Concludes that the past decade has seen:

(a) Increased awareness among Governments and the public of the implications of environmental change, and acceptance that environmental protection consists not only of pollution abatement, but also of the rational use of natural resources for sustainable development;

(b) Provision for the environment in many national constitutions and administrative structures, creation of new environmental programmes at regional and international levels, and the extension and intensification of existing ones;

(c) Increased co-operation and collaboration among and between Government and international organizations on environmental assessment and management;

(d) Efforts to protect the environment slowed down somewhat towards the end of the decade because of financial difficulties experienced by some countries;

(e) A worsening of environmental problems in developing countries arising from the present international economic order which has slowed down their development and the protection of their environment;....

3. Further considers that major achievements and failures in the implementation of the Action Plan appear to be:

... (b) In the area of environmental management:

- (i) There has been progress in the formulation of regional environmental programmes, and Governments have concluded a number of important global and regional agreements as well as drawn up principles and guidelines, although in some cases there have been delays in their implementation or observance;
- (ii) World-wide efforts have expanded to combat desertification, to improve water supply and management, and to improve human settlements although progress to implement the comprehensive United Nations action plans developed in each of these areas has remained slow;
- (iii) Progress has been made in the implementation of international scientific programmes relating to the human environment, particularly the Programme on Man and the Biosphere and the International Hydrological Programme;
- (iv) The World Conservation Strategy, which focuses on and provides guidance for sustainable development through conservation of living resources, is being used by an increasing number of Governments as a basis for national conservation programmes;
- (v) There has been progress in conceptualizing the objectives of environmental management and in developing some of its tools, such as environmental impact assessment, cost-benefit analysis and cost-effectiveness analysis;
- (vi) The need to take environmental considerations into account in the evaluation of development projects as been widely recognized;
- ... (xi) The draft principles of conduct in the field of the environment for the guidance of States in the conservation and harmonious utilization of natural resources shared by two or more States were the subject of United Nations General Assembly resolution 34/186 of 18 December 1979 and have not been widely used by Governments;

... (c) In the area of supporting measures:

- (i) Progress has been made by Governments and international organizations in encouraging environmental education, particularly following the Intergovernmental Conference on Environmental Education (Tbilisi, 1977). In the field of training, however, significant deficiencies persist. Moreover, there has been insufficient attention to environmental education, particularly at university and intermediate levels, as well as to training of workers, technicians and managers and to public education;

- ... (iii) World Environment Day (5 June) is now observed by almost all countries. The various member organizations of the United Nations system participate actively in a wide information programme catalysed by the Joint United Nations Information Committee. Despite the progress, however, the information programme is still inadequate and does not take sufficient account of regional needs;
- (iv) The United Nations Environment Programme and other organizations in the United Nations system have published many technical and general reports relevant to the environment. Coverage of environmental issues by the world media has expanded, particularly at the national level. Non-governmental organizations have made major contributions to increasing public awareness and knowledge of environmental issues. Continuation of these efforts remains important....

...II

#### New perceptions of environmental issues

1. Considers that the following new perceptions which evolved during the past decade are generally accepted and, together with the Nairobi Declaration, complement the principles contained in the Declaration of the United Nations Conference on the Human Environment:

... (b) Wise use of resources and enlightened conservation strategies are consistent with the economic growth imperative and should be considered prerequisites for sustainable growth;

(c) Imaginative research into alternative consumption patterns, technological styles and land-use strategies, and the institutional, economic, juridical and educational framework to sustain them, are called for;

(d) The important interconnections between the components and processes which support the life of the planet should be taken seriously into account in development plans. Actions which benefit one area may cause unforeseen damage in others, and the possibility of such consequences should be considered at the planning stage;

(e) Because of the great space and time variability in environmental processes and the fallibility of models of technological and social change, environmental development and management should be planned in a flexible fashion. Unexpected changes should be detected at an early stage through continuous monitoring....

...III

#### Major environmental trends, potential problems and priorities for action for the United Nations system, co-ordination by the United Nations Environment Programme, during the period 1982-1992

1. Considers that the United Nations system must be alert to and retain the necessary programme flexibility for addressing major environmental trends and problems which may emerge or become more pronounced during the coming decade;

2. The trends, problems and priorities for action which should receive attention by the United Nations system, and specifically through the system-wide programme activities co-ordinated by the United Nations Environment Programme, are listed below:

... (e) Terrestrial biota and bioproductive systems

Trends and problems: Mounting world food demand only partially satisfied because of inadequacies of production and distribution; continued severe soil degradation and desertification as a result of inappropriate agricultural practices, erosion, and deforestation; loss of agricultural land as a result of urbanization, adverse impacts on land and water resources from increasing land-use conflicts between agricultural production, fuelwood and other energy crops, protected areas and human settlements; adverse effects of slash-and-burn agriculture or other inappropriate agricultural practices; loss of potentially valuable genetic resources, including wild flora and fauna, as a result of deforestation and use and commercialization of endangered species; adverse impacts of improper or increased use of fertilizers and pesticides; depletion of wetlands;

Priority for action: Monitoring and assessment of land conditions and capability in developing countries; monitoring and assessment of tropical ecosystems including changes in forest cover; formulation and promotion of programme activities for sustainable management of soils, tropical forests, genetic resources and for combating desertification; development of environmentally sound farming and forestry practices, including agroforestry, integrated pest management and proper use of fertilizers; prevention of post-harvest food losses; reutilization of agricultural and agro-industrial residues; development of appropriate international procedures and instruments for handling and use of and international trade in pesticides; promotion of implementation of national and regional plans of action following the World Conservation Strategy; protection of wetlands and the designation of biosphere reserves; promotion of planning of urban development taking into account the needs of agricultural development and conservation of natural resources....

...IV

Basic orientations of the United Nations  
Environment Programme for 1982-1992

1. Considers that, on the basis of the new perceptions described in section II, the United Nations Environment Programme, which is the global environmental organization at Government level, in keeping with its mandate and with the support of organizations of the United Nations system, should focus its attention on three major areas and should:

(a) Stimulate, co-ordinate and catalyse monitoring and assessment of environmental problems of world-wide concern and initiate and co-ordinate international co-operation in dealing with such problems;

(b) Promote and co-ordinate appropriate policies and programmes for rational resource and environmental management as an integral part of economic and social development with particular attention to the needs of developing countries;



(c) Promote, co-ordinate and direct activities in the fields of information, education, training and national institution-building especially for developing countries, as well as the further development of environmental law and guidelines and methodologies of environmental management, and, where supplementary funds are available, assist in the implementation of these activities;

2. Further considers that with these three overall basic orientations in mind, the objectives of the Programme should be:

- (a) In the area of environmental assessment;
  - (i) To improve early warning indicators of significant environmental changes;
  - (ii) To improve the planning and co-ordination of monitoring at the global and regional levels;...
  - ... (v) To promote the establishment of reliable global, regional and national environmental statistics and state of the environment reporting as a basis for evaluating major trends and deciding on any necessary action;
- (b) In the area of environmental management;
  - ... (ii) To strive for the improvement of cost/benefit and cost/effectiveness evaluation of environmental measures, environmental assessment of development activities and integrated physical planning for rational use of natural resources;
  - (iii) To promote the adoption and implementation by States of legal and other appropriate instruments for assessing the effects on the environment of potentially harmful activities under their jurisdiction and control, as well as the dissemination of information and the public use thereof;
  - (iv) To promote the development of more cost-effective solutions to environmental management problems, in particular such solutions adapted to the needs of developing countries;...
  - ... (vi) To promote and continue to contribute to the activities of the United Nations system in the area of the interrelationships among population, resources, environment and development;
- (c) In the area of supporting measures;

- (i) To strengthen the existing arrangements within the United Nations Environment Programme and between it and the United Nations Development Programme and other organizations of the United Nations system with a view to enhancing the capacity of developing countries to deal with their environmental problems and concerns, including methodologies of sound environmental management, as part of their sustainable economic and social development;
- (ii) To promote and facilitate the strengthening, within countries, of institutional arrangements for effective assessment of environmental impact of development and environmental management;
- (iii) To promote, co-ordinate and catalyse, in co-operation with relevant institutions of the United Nations system, activities in the area of environmental education and training and public awareness with particular emphasis on:
  - a Application of new education methods and better teacher training programmes through research and institution-building and the integration of an environmental component into school curricula, and seeking to improve the quality of education and training through making adaptations to existing facilities;
  - b Increased training of specialists in various fields of environmental activities;
  - c Better dissemination of information to the media, the general public and scientific audiences;
  - d Integration of an environmental component in the training of enterprise managers, technicians, skilled workers and decision-makers concerned with environmental and resource management;
- (iv) To encourage national and regional arrangements for the provision of information on crucial and emerging environmental issues, for example on the use of technology and products condemned in the country of origin;
- (v) To support Governments and non-governmental and youth organizations in their efforts to increase environmental awareness and to encourage Governments to provide for strong public participation in the planning and implementation of environmental activities;

- (vi) To encourage and facilitate the development of legal instruments relating to the environment at the national and international levels and to monitor their implementation; and, within its mandate, to promote the development of further guidelines, principles or agreements and to facilitate their application in areas of global and regional environmental concern in co-operation with the responsible international organizations....

... 3. Considers also that in pursuing the above-mentioned objectives, the United Nations Environment Programme should be guided by the major environmental trends, potential problems and priorities for action identified in section III, and should concentrate in particular on: promotion of land and water management, including control of desertification and deforestation; protection of natural resources; promotion of the International Drinking Water Supply and Sanitation Decade; promotion of new and renewable sources of energy; promotion of regional seas programmes; prevention of environmental disturbances from air pollution; promotion of chemical safety and control of hazardous substances;

Planning and implementation of environmental activities

1. Solemnly urges Governments:...

... (c) To fit management techniques to environmental circumstances in dealing with sectoral problems;

2. Invites all Governments, intergovernmental organizations and non-governmental organizations to ensure that the priorities for action mentioned in section III above are accorded high priority within their respective programmes;...

... 4. Also invites the governing bodies of the relevant organizations of the United Nations system to integrate the major environmental trends over the next ten years effectively in their action plans, and, on the basis of those trends, in close co-operation with the United Nations Environment Programme, to draw up appropriate measures for environmental protection with due regard to available resources;...

Resolutions and recommendations of the Intergovernmental Regional Meeting on the Environment in Latin America and the Caribbean

The Governing Council,

Meeting in a session of a special character,

Considering that the countries of the Latin American region, on the invitation of the Government of Mexico and with the support of the United Nations Environment Programme, held an Intergovernmental Regional Meeting on the Environment in Latin America and the Caribbean from 8 to 12 March 1982 in preparation for the session of a special character and the tenth session of the Governing Council of the United Nations Environment Programme,

Considering further that the purpose of the Governments of the Latin American and Caribbean region assembled at the above-mentioned Meeting was to formulate the policy principles that should guide the development of environmental activities in the region that the purpose of the Meeting was also to review the major achievements in the implementation of the Stockholm Action Plan for the Human Environment, and that it was the intention of the participants to draw up resolutions and recommendations with respect to the major environmental trends to be addressed by the United Nations Environment Programme over the forthcoming ten years,

Takes note of the resolutions and recommendations of the Inter-governmental Regional Meeting on the Environment in Latin America and the Caribbean, contained in annex V to the final report of the Meeting,

Requests the Executive Director to transmit the resolutions of the meeting to the Governing Council at its tenth session for its consideration.

10/2. Regional presence of the United Nations Environment Programme

The Governing Council,

...I. Regional needs

Expresses the view that arrangements for the regional presence of the United Nations Environment Programme should take fully into account the specific situations and needs of the various regions;

II. Regional presence in Africa and Asia and the Pacific

1. Requests the Executive Director to strengthen the regional presence of the Programme by restoring, within available resources, the financial support of the regional advisory services to levels commensurate with the need of the African and Asia and the Pacific regions;
2. Further requests the Executive Director to consider the possibility of utilizing the regional offices as a forum for periodic consultations among Governments;
3. Also requests the Executive Director, in co-operation with other organizations within and outside the United Nations system, to involve the scientific community and other relevant professional groups in furthering the co-operative efforts among Governments of these two regions;

III Regional presence in Latin America and the Caribbean

1. Invites Governments of Latin America and the Caribbean to consider convening periodic inter-governmental regional meetings on the environment in Latin America and the Caribbean for the purpose of formulating policies and a strategy for the region in this field/

2. Requests the Executive Director to provide secretariat support for such intergovernmental regional meetings through the Regional Office for Latin America and the Caribbean;

3. Invites Governments of Latin America and the Caribbean to consider the possibility of holding meetings of government-nominated experts sufficiently in advance of sessions of the Governing Council to enable them to review the technical aspects of regional environmental programmes;

4. Authorizes the Executive Director to strengthen the Regional Office for Latin America and the Caribbean by providing it, within available resources and without prejudice to support for the Environment Co-ordination Unit in the Regional Commission for Latin America, with the necessary financial resources and staff for the full performance of the functions required under this decision, so that it can serve as an effective instrument for the co-ordination of co-operative environmental efforts in the region;

IV. Structure and terms of reference of the regional offices and environment co-ordination units in Africa, Asia and the Pacific and Latin America and the Caribbean

1. Endorses the views of the Executive Director with respect to the integration of the regional advisory services and regional information support services into the regional offices of the United Nations Environment Programme for Africa, Asia and the Pacific, and Latin America and the Caribbean;

2. Further requests the Executive Director to continue to provide, at the present level, institutional support to the environment co-ordination units of the economic commissions for Africa, Asia and the Pacific, and Latin America and the Caribbean commensurate with their needs;

3. Considers that the terms of reference proposed for the regional offices and environment co-ordination units in Africa, Asia and the Pacific, and Latin America and the Caribbean, as they appear in annex I to the Executive Director's report, are appropriate and will help minimize overlap;

The Governing Council,

... 1. Authorizes the Executive Director to convene a meeting of Government-nominated experts to elaborate a strategy for regional co-operation programmes on environmental matters and the priorities for implementing them, taking into account existing subregional programmes, as well as priorities indicated by national reports;

2. Recommends that the expert meeting take into account among the aims for future intraregional co-operation on environmental affairs the strengthening of existing mechanisms for integration and the approval of specific agreements on co-operation in the environmental field;

Holding the view that the programme of activities of the United Nations Environment Programme should be extended to other forests, especially the forests of the Mediterranean,

Requests the Executive Director to include in the system-wide medium-term environment programme a programme of activities designed to ensure, taking into account the responsibilities of the Food and Agriculture Organization of the United Nations, and the United Nations Educational, Scientific and Cultural Organization, the conservation, rational management and development of forests, which are also effective means of combating erosion and desertification, particularly in developing countries.

Tropical forests

1. Takes note of the recommendations of the meeting of experts regarding a co-ordinated and harmonized international programme of activities in support of national efforts for rational management of tropical forest resources and calls upon the Executive Director to consider using regional arrangements, where they exist, to further that programme;

2. Requests the Executive Director to transmit the recommendations to all Governments and to multilateral agencies and other international and regional organizations, including financial institutions and concerned non-governmental organizations;

4. Further requests the Executive Director to report to the Governing Council at its eleventh session on the results of the consultations;....

### Implementation of the Plan of Action to Combat Desertification

1. Notes the action taken by Governments, the United Nations Environment Programme, and other members of the United Nations system for the implementation of the Plan of Action to Combat Desertification;

2. Notes also the results of the third session of the Consultative Group for Desertification Control, and urges the Group to continue and intensify its efforts to assist the Executive Director in the mobilization of resources for the formulation and implementation of projects and programmes within the framework of the Plan of Action and in ensuring proper co-ordination of activities carried out with resources mobilized by the Group;

3. Urges all Governments, organizations of the United Nations system, other intergovernmental bodies, non-governmental and all other organizations to augment their efforts to prevent and combat desertification in order to accelerate progress in implementing the recommendations of the Plan of Action for immediate initial action;

4. Takes note of General Assembly resolution 36/191 of 17 December 1981 concerning a study of financing the Plan of Action to Combat Desertification, and urges all Governments to respond favourably and promptly to the Secretary-General's enquiries undertaken in pursuance of the resolution;

5. Requests the Executive Director to take note of and use the results of the Meeting of Government-designated Experts on Desertification in the Americas and the Caribbean, held at Cocoyoc, Mexico, from 8 to 12 February 1982, for future action in the area of desertification at both the hemispheric and the global levels;

6. Authorizes the Executive Director to transmit his report on the implementation of the Plan of Action to Combat Desertification, 25/ and the decision of the Governing Council thereon, on the Council's behalf, to the General Assembly at its thirty-seventh session, through the Economic and Social Council, as the biennial report of the Council to the Assembly on the implementation of the Plan of Action.

10/18. Implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian Region

The Governing Council,

- ... 1. Welcomes the efforts made and results achieved by the United Nations Sudano-Sahelian Office, and urges the Office to continue its efforts in terms of vigorous support for desertification control activities in the region, on behalf of the United Nations Environment Programme;
2. Expresses however its serious concern at, on the one hand, the persistence and aggravation of the desertification process in the Sudano-Sahelian region and, on the other, the slowness with which the Plan of Action to Combat Desertification is being implemented;
3. Urges all Governments, the organizations of the United Nations system, intergovernmental and non-governmental organizations, and concerned individuals to extend their support to the Governments and peoples of the countries of the Sudano-Sahelian region in their efforts to combat desertification;

Authorizes the Executive Director to continue to contribute to the United Nations Sudano-Sahelian Office, after consultations with the Administrator of the United Nations Development Programme, the Environment Programme's share of the administrative and operational costs of the joint venture for 1982-1983, on the basis of the mutually agreed work plan;
5. Further urges the Executive Director to provide additional resources to facilitate a process of exchange of information and expertise among the countries of the Sudano-Sahelian region and between them and the other countries of the African region which have similar problems;
6. Authorizes the Executive Director to submit his report on the implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian Region 29/ and the present decision, on behalf of the Governing Council, to the General Assembly at its thirty-seventh session;
7. Requests the Executive Director, in the light of the situation in the Sudano-Sahelian region, to strengthen the support of the Programme for the United Nations Sudano-Sahelian Office, and to report to the Governing Council at its eleventh session on the implementation of the present decision.

10/25. Environmental education and training

A. Environmental education and training in Africa

The Governing Council,

- ... 1. Requests the Executive Director to enhance the role of the United Nations Environment Programme in promoting, co-ordinating and catalysing activities in the field of environmental education and training, including public awareness;



2. Further requests the Executive Director, in co-operation with relevant international organizations, to continue rendering support to environmental education and training programmes in the African region with a view to:

(a) Advising on the incorporation of environmental components into curricula of all institutions of learning at all levels of education, and into adult education;

(b) Identifying and promoting national, regional and subregional institutions and programmes offering environmental education and training in the African region with a view to strengthening them;

(d) Strengthening the capabilities of the Regional Office for Africa to enable it to co-ordinate, in conjunction with the Regional Office for Education in Africa of the United Nations Educational, Scientific and Cultural Organization, environmental education and training programmes in Africa;

3. Requests the Executive Director to convene a meeting of experts from Governments and the scientific community within the region to develop a programme of action for environmental education and training in the region;

4. Requests the Executive Director to report to the Council at its eleventh session on the progress in the implementation of the present decision.

B. Environmental training for Latin America and the Caribbean

The Governing Council,

... 1. Reaffirms its strong support for the consolidation of the network of environmental training institutions as a priority need for the countries of Latin America and the Caribbean, and requests the Executive Director to treat the network as a permanent environmental training programme in these countries and as a demonstration programme at the general level;

2. Requests the Executive Director to take the appropriate steps to launch the activities of the network for a period of two years, during which the Governments of Latin America and the Caribbean should determine the forms to be taken by their support and participation in the activities of the network, and also to utilize and reinforce supporting and advisory services by other agencies concerned with environmental training, particularly the United Nations Educational, Scientific and Cultural Organization;

3. Urges the Governments of Latin America and the Caribbean to designate national organizations for the implementation of the programme and the establishment of machinery to co-ordinate the various national agencies capable of contributing to the tasks of environmental training at the regional level;

4. Requests the institutions to provide logistic support for the execution of the network's activities and the international financing agencies to give the necessary priority to environmental training projects submitted by the network;

5. Declares that the activities of the network should be directed towards all the countries of the region, and also requests the Executive Board of the International Centre for Training in Environmental Sciences, in developing its training activities, to meet the language requirements which this involves;

II

1. Requests the Executive Director to take the appropriate steps to ensure the continuation of the activities of the International Centre for Training in Environmental Sciences beyond 31 December 1982 on the basis of the draft Agreement drawn up for this purpose by the United Nations Environment Programme and the Government of Spain and having regard to the recommendations on the final text that may be made by the Executive Board of the Centre at its second regular session, to be held at Madrid from 7 to 9 June 1982;

2. Recommends that the Executive Director take such measures as he may consider desirable to ensure close mutual co-operation between the Programme and the Centre in the environmental training activities intended for the Latin American and Caribbean countries and Spain and to determine the possible financial support for the implementation of the Agreement.

10/26. Additional resources for dealing with serious environmental problems in developing countries

(b) Incorporating environmental subjects into curricula of all institutions of learning at all levels of education, and into adult education;

2. Also requests the Executive Director to convene, within available resources, a meeting of experts from Governments, the academic community and the scientific community within the region to develop a programme of action for environmental education and training, as well as public awareness, in the region;

B. Environmental education and training in Latin America and the Caribbean

The Governing Council,

... 1. Commends the administrative structure of the Network of Environmental Training Institutions in Latin America and the Caribbean, which has proved an appropriate and effective instrument for the implementation of its actions;

2. Recommends to Governments that they should intensify support for the Network and co-operate with the Co-ordination Unit in the Regional Office for Latin America and the Caribbean, by means of scholarships and joint publications, giving impetus to the operation of a fund for fellowships and services;

3. Requests the Executive Director to disseminate information on the experience of the Network so that the results already achieved can serve as a guide for similar efforts in other developing regions;

4. Recommends to the Executive Director, bearing in mind the catalytic role of the United Nations Environment Programme, that he continue financial support to the Network, especially in its initial phase, by increasing, within available resources, support for environmental training;

C. Information

The Governing Council,

... 1. Notes with satisfaction the statement made by the Executive Director that a reform of public information activities is being undertaken inter alia to streamline the publications programme, so as to ensure closer co-operation with, and dissemination of information through, non-governmental organizations and communication of information to the regions and media;

2. Recommends that such reform be based on a cost-effectiveness analysis to be commissioned from a consultant specializing in the field of information and communications technologies, whose terms of reference should include examination of the target groups for the various information activities, the present and projected impact thereof, current estimated costs and suggested improvements, especially in relation to the needs of developing countries;

3. Requests that this cost-effectiveness analysis should pay particular attention to the viability of Mazingira;

4. Further requests the Executive Director to communicate the results of the cost-effectiveness analysis to Governments, and to seek their views in order that he may report to the Council at its twelfth session;

5. Urges that the United Nations Environment Programme extend its support for regional information activities;

6. Requests the Executive Director to ensure that reports resulting from projects sponsored by the Programme are distributed to Governments and, within available resources and whenever appropriate, to scientific institutions and non-governmental organizations, especially in developing countries.;

D. Public information in Africa and Asia and the Pacific

The Governing Council,

... Requests the Executive Director:

(a) To provide for a well-oriented public information programme to suit the needs of the African and Asia and the Pacific regions;

(b) To improve the circulation of publications of the United Nations Environment Programme so as to reach the greatest possible number of readers;

(c) To explore, with the aid of experts from the regions, the best possible methods of adapting the appropriate available public information material, including audio-visual presentations, on critical environmental issues, and to take necessary action to enable it to reach the greatest possible number of people;

PART SIX: TERRESTRIAL ECOSYSTEMS: GENETIC RESOURCES

The Governing Council,

Noting that in the proposed programme budget of the United Nations Environment Programme for the first biennium (1984-1985) of the system-wide medium-term environment programme priority has been given to the continued collection and registration of crop and tree genetic resources and related wild strains,

Noting further that in the programme second priority has been given to the establishment of gene banks and registers for animal breeds,

Concerned at the increasing genetic erosion in the world, which can have dangerous effects on, inter alia, world food production, the production of medicines and other pharmaceutical products, and other benefits for mankind.

Convinced of the need to preserve genetic diversity through protection of animal and plant habitats, wildlife management and plant conservation programmes and intensive study and cataloguing of animal and plant species, including those which may at present be of little economic value;

1. Requests the Executive Director, in co-operation with Governments and relevant intergovernmental and non-governmental organizations, to continue to promote the in situ conservation of endangered animal and plant genetic resources;

2. Further requests the Executive Director to encourage the relevant international organizations to extend coverage of registers and gene banks to include all endangered plant and animal genetic resources;

PART SEVEN: ARID AND SEMI-ARID LAND ECOSYSTEMS AND  
DESERTIFICATION CONTROL: DESERTIFICATION IN AFRICA

A. Implementation of the Plan of Action to Combat Desertification

The Governing Council,

- ... 1. Invites all Governments and international organizations concerned and interested to facilitate the task of the Consultative Group for Desertification Control to enable it to achieve the objectives assigned to it;
2. Appeals to all concerned Governments and organizations to exert every effort to support and strengthen the role of the Consultative Group;
3. Invites the General Assembly to consider expanding the role of the Consultative Group to include also information exchange;
4. Appeals to countries to contribute financially to the implementation of the Plan of Action to Combat Desertification, thus bringing into effect General Assembly resolution 33/116 C, section IX, of 29 January 1979, which created the Special Account for that purpose;
5. Requests the Executive Director to pursue his efforts to persuade Governments to make their views known in reasonable time, in particular with special reference to the provision of additional resources for the financing of the Plan of Action;

B. Implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian region

The Governing Council,

- ... 1. Expresses its satisfaction at the progress made by the United Nations Sudano-Sahelian Office in assisting the Governments of the region, on behalf of the United Nations Environment Programme, and under the joint venture with the United Nations Development Programme, in the implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian region;
2. Appeals to all Governments, organizations of the United Nations system and intergovernmental and non-governmental organizations to give due consideration to strengthening efforts and support for desertification control in the region;
3. Requests the Executive Director to continue the support of the United Nations Environment Programme for the joint venture at a level commensurate with the pressing needs of the Sudano-Sahelian region;
4. Authorizes the Executive Director to submit his report on the implementation of the Plan of Action in the Sudano-Sahelian region, and the present decision, on behalf of the Council, to the General Assembly at its thirty-eighth session through the Economic and Social Council;
5. Invites the General Assembly to consider:

~~(a) Expanding the mandate of the United Nations Sudano-Sahelian Office into the area of dealing with the environmental consequences of drought, in addition to those of desertification, in the Sudano-Sahelian region as a whole;~~

(b) Working out appropriate institutional and other relevant arrangements which would enable that Office to be charged with such an additional responsibility;

###### The Governing Council

... 1. Requests the Executive Director to accord high priority in the provision of assistance to African countries to dealing with the most urgent environmental problems in Africa, namely:

Invites the Governments of the region to convene, in co-operation with regional organizations and institutions, an African environmental conference to discuss national environmental priorities and identify common problems worthy of a regional programme of action to deal with serious environmental problems in Africa;

3. Requests the Executive Director to instruct the Regional Office for Africa to provide secretariat services for the conference;

##### B. Regional activities in Asia and the Pacific

###### The Governing Council,

... 1. Requests the Executive Director to provide, within available resources, financial support towards the strengthening of regional activity, including support to regional and subregional programmes and to the Environmental Co-ordinating Unit of the Economic and Social Commission for Asia and the Pacific;

C. Year of the Trees (1988) for Asia and the Pacific

Recognizing the serious state of deforestation and degradation of forest resources in the member countries of the region covered by the South Asia Co-operative Environment Programme;

1. Commends the initiatives taken by the countries of the South Asia Co-operative Environment Programme, at their first Governing Council meeting to overcome the deforestation problem in the region by designating 1988 as Year of the Trees for South Asia;

2. Invites other countries in the Asia and the Pacific region to consider designating 1988 as Year of the Trees;

3. Requests the Executive Director to support, within available resources, the formulation of projects and programmes by the secretariat of the South Asia Co-operative Environment Programme in connection with the Year of the Trees, and to assist in soliciting support from donor agencies for the implementation of those activities;

D. Regional activity in Europe

The Governing Council,

... 2. Requests the Executive Director to respond favourably to the recommendations of the Senior Advisers to ECE Governments on Environmental Problems for a continuation of financial support from the United Nations Environment Programme for the European Monitoring and Evaluation Programme, in the minimal amount required and on a transitional basis, not to extend past 1984;...

... 4. Further requests the Executive Director to consider favourably, within available resources, requests by the Executive Secretary of the Commission for support to appropriate projects;....

The Governing Council

... 1. Expresses its appreciation to the Executive Director for convening the Meeting of Government-nominated Experts on Regional Environmental Programmes in Latin America and the Caribbean at Buenos Aires from 14 to 17 March 1983, for the general purpose of arriving at concrete recommendations for intraregional co-operation in the field of the environment, and for providing secretariat support through the Regional Office for Latin America and the Caribbean;

2. Decides:

(a) To support the strengthening of regional and subregional activities in Latin America and the Caribbean within the general policy of, and resources available to, the programme of the United Nations Environment Programme;

(b) To urge Governments and international organizations to strengthen their efforts to support the ongoing programmes, co-ordinated by the United Nations Environment Programme, of the Latin American Environmental Training Network, the Action Plan for the Protection of the Marine Environment and Coastal Areas of the South-East Pacific and the Action Plan of the Caribbean Environment Programme;

(c) To recommend that future intergovernmental meetings on the environment in the Latin America and Caribbean region be preceded by meetings of high-level experts designated by Governments, convened by the Executive Director, for the purpose of considering the technical aspects of regional and subregional environmental programmes;

(d) To request the Executive Director that the objectives of the regional and subregional programmes designated as of common interest which were adopted at the Meeting of Government-nominated Experts, and which appear in the report of the Meeting, be considered within the framework of the medium-term plan of the United Nations Environment Programme, and that he consider the possibility of an early start on their implementation;

(e) To invite the various regional intergovernmental agencies and the organizations of the United Nations system according to their mandate, to participate in the formulation and implementation of the programmes;

(f) To invite also, after consultation with Governments, the participation of those non-governmental organizations which can support the formulation and implementation of the programmes;

(g) To request the Executive Director that intraregional co-operation in the implementation of regional environmental programmes be given special consideration so as to strengthen the regional component of the system-wide medium-term environment programme.

12/10. Desertification

The Governing Council,

- ... 1. Expresses its appreciation to the Executive Director for his comprehensive and action-oriented report;
2. Also expresses its appreciation to the Administrative Committee on Co-ordination for its analytical report;
3. Notes with great concern that during the period under review desertification has continued to spread and intensify in developing countries, and particularly in Africa;
4. Reconfirms the validity of the Plan of Action to Combat Desertification, and the general appropriateness of the institutional arrangements established by the General Assembly for the follow-up of its implementation;
5. Endorses the view of the Executive Director that the implementation of the Plan has to be more focused on the most affected countries and on actions to arrest desertification giving priority to areas offering the best chances for substantial rehabilitation;
6. Expresses its satisfaction with the initiative of the Secretary-General of the United Nations in establishing the Office of the United Nations Secretary-General's Special Representative on the African Social and Economic Crisis, a crisis caused among other things by prolonged drought;
7. Appeals to all Governments, organizations of the United Nations system and other intergovernmental and non-governmental organizations to give due consideration to strengthening their financial and technical support to the countries of the Sudano-Saharan region;
8. Takes note with satisfaction of the positive experiment undertaken by the United Nations Sudano-Saharan Office as a United Nations Development Programme/United Nations Environment Programme joint venture in providing support to nineteen African countries, on behalf of the United Nations Environment Programme, in implementing the Plan of Action;
9. Requests the Executive Director to approve for the United Nations Sudano-Saharan Office concrete biennial programmes with specific goals to allow the governing councils of both the United Nations Environment Programme and the United Nations Development Programme to measure achievements within the framework of the implementation of the Plan of Action;

10. Decides to include Ghana and Togo among the countries eligible to receive assistance through the United Nations Sudano-Sahelian Office in implementing the Plan of Action;

11. Urges Governments of countries suffering from or prone to desertification to consider favourably giving priority to the establishment of national programmes to combat desertification and also to consider establishing appropriate national machinery for that purpose, bearing in mind as appropriate the recommendations contained in chapter VII, section C, of the report of the Executive Director, and to give particular emphasis to designing such programmes in harmony with existing social, cultural and ecological systems of the peoples involved;

12. Authorizes the Executive Director to assist, as appropriate, Governments which so desire in the above endeavours;

13. Also authorizes the Executive Director to assist Governments in applying, in the context of the implementation of the Plan of Action, appropriate land use policies in arid, semi-arid and subhumid regions suffering from intensive soil degradation which diminishes the potential of the land;

14. Urges Governments and international bodies to consider:

(a) Examining their ongoing and planned development projects to ensure maximum effectiveness in combating desertification;

(b) Completing the national assessments of desertification and establishing mechanisms to monitor the status and trends;

(c) Reviewing and revising accordingly policies and practices which serve as impediments or disincentives to successful desertification control measures at the local level;

15. Emphasizes the importance of regional co-operation as an effective means of increasing the efficient use of financial and technical resources, with particular emphasis accorded to co-operative research, training and information exchange;

16. Reaffirms the importance of the role of non-governmental organizations in the implementation of action-oriented projects, and the need for continuing support for their actions;

17. Reaffirms the central role of the United Nations Environment Programme in catalysing, co-ordinating and assessing the implementation of the Plan of Action at the international level;

18. Calls upon all countries, in particular developed countries and those in a position to do so, to increase their assistance to countries suffering from desertification, including the financing of subregional and regional programmes, and to contribute to the Special Account created under General Assembly resolution 32/172 of 19 December 1977;

19. Welcomes General Assembly resolution 38/163 of 19 December 1983 and fully supports the intention of the Executive Director to request, on behalf of the Secretary-General, all Member States that have not yet done so to provide as soon as possible their comments to the Secretary-General in order to allow the General Assembly to consider taking a decision at its fortieth session on measures designed to obtain additional and predictable financing;

20. Invites all Governments, particularly those of donor members, to become more involved in the work of the Consultative Group for Desertification Control, especially in the process of formulation of projects to be presented to the Group;

21. Requests the Executive Director to consider the implementation, in permanent consultation as the case may be with the Governments concerned, the Consultative Group for Desertification Control, regional organizations and regional intergovernmental meetings, of the recommendations for regional action and overall support contained in chapter VII, sections D and F, of his report;

22. Decides:

(a) To request the United Nations Development Programme, the United Nations Fund for Population Activities and the other United Nations organs concerned to implement their agreement in the Environment Co-ordination Board in 1978 to provide additional staff support for the Desertification Branch;

(b) To authorize the Executive Director, should no response, or only a partial response, to that request have been received within six months, to seek from the Governing Council, if necessary, the appropriations to enable him to make use of up to five posts, as required, from those frozen for 1984-1985 to supplement the present establishment of the Branch;

(c) To request Governments in a position to do so to second qualified and experienced personnel to the Desertification Branch at their own expense, the numbers, duration of assignment and specific functions of such personnel to be at the discretion of the Executive Director;

23. Further decides to give the Desertification Branch a greater degree of autonomy in fulfilling its functions by establishing it as a programme activity centre, with the priority tasks of building up and disseminating to Governments a data base on desertification control, including case-studies, evaluations, national focal points concerned with developing national programmes, projects being undertaken, sources of expertise within countries, individual experts with relevant experience, non-governmental organizations active in the field, etc., drawing, where possible, on information already available within and outside the United Nations Environment Programme, notably the Global Environmental Monitoring System and the International Referral System for sources of environmental information;

24. Invites the General Assembly to expand the role of the Consultative Group for Desertification Control to include explicitly responsibility for advising the Executive Director on:

(a) The progress and effectiveness of activities implemented under the Plan of Action, identifying constraints and possible solutions to problems, taking account of relevant evaluations and case-studies;

(b) Programme priorities of the United Nations Environment Programme;

(c) Measures required to improve implementation of the Plan of Action on a regional and world-wide basis;

25. Requests the Executive Director to examine and clarify the functions and outputs of the Inter-Agency Working Group on Desertification, and to recommend to the Governing Council at its thirteenth session appropriate changes for action to ensure full consultation and co-operation between the agencies of the United Nations;

26. Authorizes the Executive Director, in accordance with the relevant resolutions of the General Assembly, to submit on behalf of the Governing Council a progress report on the implementation of the Plan of Action to Combat Desertification, based on the relevant parts of his annual report and the comments of the Governing Council thereon, to the General Assembly at its thirty-ninth session through the Economic and Social Council;

27. Also authorizes the Executive Director to submit on behalf of the Governing Council, in accordance with the relevant resolutions of the General Assembly, a progress report on the implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian region, based on the relevant parts of his annual report and the comments of the Council thereon, to the General Assembly at its thirty-ninth session through the Economic and Social Council;

28. Decides that a further overall assessment of progress in the implementation of the Plan of Action to Combat Desertification should be carried out in 1992;

29. Requests the Executive Director to report to the Governing Council at each of its sessions on progress in the implementation of the Plan of Action to Combat Desertification.

Recommends to the Governments of the countries of the region that they agree as soon as possible on a general programme for the Environmental Training Network in Latin America and the Caribbean which reflects the agreements reached on this subject and the undertaking on the part of the Governments of Latin America and the Caribbean concerning the administrative and financial aspects which, in accordance with their abilities, they might assume responsibility for in order to strengthen and consolidate the programme of the Environmental Training Network;

2. Recommends to the Governments of the countries of the region that they study a regional co-ordination project concerning the Network for the possible purpose of attaining the signature of an instrument on the subject which, duly submitted to the United Nations Environment Programme, would guarantee the financing of the Network's programme up to 1987; in this financing, the contributions in local currency and in kind from the countries will constitute the regional counterpart under the project to be submitted to the Programme;

5. Urges the Executive Director to take the necessary measures for a continuation of budgetary support to the Network within available resources;

3. Requests the Executive Director, within available resources, to strengthen the Regional Office for Africa in terms of human and financial resources taking into account the establishment of the subregional focal points;

4. Requests the Executive Director to make a study on the establishment of subregional offices in the future, considering the offer of Morocco to host the subregional office for North Africa;

5. Further requests the Executive Director to report to the Governing Council at its thirteenth session on the implementation of the present decision.

C. Regional activities in Asia and the Pacific

The Governing Council,

... 1. Requests the Executive Director to continue to accord his priority within available resources to the regional and subregional environmental programmes of the Asia and Pacific region, and to provide financial support and other assistance commensurate with the region's needs, underscoring the urgency of such programmes;

Also requests the Executive Director to intensify his efforts to seek support and funds from bilateral and multilateral sources, traditional as well as new, for priority activities in the subregional and regional programmes of the Governments of the region identified through the clearing-house mechanism;

Views of the Governing Council concerning the document prepared by the Special Commission entitled "World Commission on Environment and Development: Mandate, key issues, strategy and work plan" for transmission to the Commission

1. The Governing Council notes the Commission's preliminary assessment, as reflected in the Commission's document, that environmental problems arise in the policies and practices operative in sectors of development such as agriculture, industry, human settlements, water, energy, forestry, etc., and that in order to deal effectively with those problems, it is necessary to ensure that incentive systems, policies, legislation and regulations should be guided, inter alia, by considerations of environmental protection and improvement.

...ANNEX

Recommendations of the Executive Director concerning the environment in the dialogue between and among developed and developing countries

- ... 2. The Governing Council may also wish to decide upon the issues which it would most appropriately address itself, either at sessions of the Council or through interested groups of Governments consulting among themselves with a view to reaching agreements on concrete co-operative activities and keeping the Council informed of progress in this respect.
3. Some prerequisites for potential success in such consultations are:
- (a) Respect for the sovereignty of States over their own natural resources;
- (b) Reaffirmation of a concept of development which acknowledges social elements in addition to pure economic growth, and which depends on the rational use of natural resources. This does not mean under-utilization or no utilization at all - rather, it means finding the best ways of exploitation that do not destroy the resource base itself in the process;
- (c) Recognition that availability of resources is a function of technology and education - hence the essential need for co-operation in the training and in the transfer of technology;
- (d) Acceptance of the fact that environmental concerns are not only long-term considerations and even where they are, require to be dealt with through actions needed in the short term. Conversely, the ways in which short-term problems are solved have many implications for environment now and in the years to come.
4. Issues for such consultations may include:...
- ...(b) For co-operation among developing countries:...
- ...(vii) Development of common basic principles and guidelines for resource use and environmental protection;...
- ...(c) For co-operation between developed and developing countries:
- ...(ii) Rational use of tropical forests:
- Countries importing tropical forest products could agree with exporting countries in the following areas:
- a. Carrying out of co-operative studies on the least damaging ways of harvesting tropical forest products;
- b. Support of fuelwood plantations to minimize pressure on tropical forests and hence attendant environmental hazards;

(iii) Loss of genetic resources:

The loss of genetic resources may be remedied, at least partially, through the leasing by developing countries of natural areas considered to be of actual or potential importance for genetic material to other States or bodies with a view to generating the resources needed for environmental protection in the economic and social context of the leasing country...;

... (d) Drought and desertification:

- (i) Establishment in the countries most hard hit by drought of development plans which take account of its inevitable recurrence;
- (ii) Establishment of a network of institutes which would specialize in the application of new scientific knowledge to locally developed techniques and technologies in agriculture, silviculture, range management and use of water resources;
- (iii) Establishment of a mechanism to support regional training centres or networks for training the large body of skilled professionals and technicians needed by the developing countries in various fields of desertification control...;

... (f) Pool of experts

Establishment of a pool of experts from both developed and developing countries in the various aspects of environmental impact assessment and environmental cost-benefit analysis, to be financed from special voluntary accounts established by Governments for that purpose with an international organization, on which any country could draw for study of the environmental aspects of its major development activities...;

... (h) Some unresolved or emerging environmental issues:

Establishment of an intergovernmental expert group (with balanced representation of developed and developing countries), in which representatives of industry and parliamentary bodies should participate, to discuss some of the unresolved or emerging environmental issues. This expert group should make concrete recommendations to the Governing Council on how to reach solutions to these issues in a co-operative rather than a confrontational manner. Such issues may include:

- ... (ii) Conditions of transfer of environment-protection technologies...;
- (iv) Establishment of a code or codes of environmental conduct or an international ecological order.

6. Urges the Executive Director to maintain the necessary flexibility to support the initial stages of the co-ordination machinery through the allocation of the catalytic resources referred to above for the Network programme in 1986-1987.

Urges States to take all necessary steps at the national, regional and international levels to set up or improve biosphere reserves and take part in the development and operation of the world network of biosphere reserves, paying particular attention to the establishment and adequate maintenance of biosphere reserves considered to be of special international importance;

2. Invites the Executive Director, in co-operation with the United Nations Educational, Scientific and Cultural Organization, the Food and Agriculture Organization of the United Nations and the International Union for Conservation of Nature and Natural Resources, to extend all possible support and assistance to the implementation of the Action Plan, and to report to it at its fourteenth session on progress achieved in this respect.

13/28. Implementation of the Action Plan for Biosphere Reserves

The Governing Council,

1. Urges States to take all necessary steps at the national, regional and international levels to set up or improve biosphere reserves and take part in the development and operation of the world network of biosphere reserves, paying particular attention to the establishment and adequate maintenance of biosphere reserves considered to be of special international importance;

2. Invites the Executive Director, in co-operation with the United Nations Educational, Scientific and Cultural Organization, the Food and Agriculture Organization of the United Nations and the International Union for Conservation of Nature and Natural Resources, to extend all possible support and assistance to the implementation of the Action Plan, and to report to it at its fourteenth session of progress achieved in this respect.

13/29. Preparation of national conservation strategies

The Governing Council,

- ... 1. Requests the Executive Director to approach those Governments that have not taken steps to prepare national conservation strategies, to encourage them to initiate that process;

A. Implementation of the Plan of Action to Combat Desertification

The Governing Council,

... Noting that at its twelfth session it endorsed the view of the Executive Director that the implementation of the Plan of Action to Combat Desertification must be focused more on the most affected countries and on actions to arrest desertification, giving priority to areas offering the best chances for substantial rehabilitation,

Noting also that at its twelfth session it took note with satisfaction of the positive experiment undertaken by the United Nations Sudano-Sahelian Office as a United Nations Development Programme/United Nations Environment Programme joint venture in providing support to 19 African countries, on behalf of the United Nations Environment Programme, in implementing the Plan of Action,

Reaffirming its views expressed at previous sessions regarding the continuing environmental degradation resulting from the process of desertification in the developing countries, especially in Africa, where persistent drought triggering serious desertification in areas not normally seriously affected is reaching levels of disaster and crisis,

Noting with concern the slow implementation of the Plan of Action,

1. Expresses appreciation to the members of the international community for the emergency assistance offered to countries facing famine;
2. Notes the activities undertaken by Governments and international regional and non-governmental organizations in combating desertification and urges them to continue communicating information on their actions to the United Nations Environment Programme for inclusion in its reports in an endeavour to disseminate information and experience;

3. Calls upon Governments of affected countries to prepare national plans for combating desertification and to integrate them into their comprehensive national development plans;
4. Calls on donor countries and others in a position to do so to assist affected countries in their endeavours to curb desertification;
5. Decides to review at its fourteenth session the status and validity of the Special Account created under General Assembly resolution 32/172, on the basis of a report to be prepared by the Executive Director after consultation with Governments;
6. Expresses its concern about the lack of adequate response with respect to the important series of studies conducted by the United Nations Environment Programme on additional and predictable financial resources for the implementation of the Plan of Action to Combat Desertification, and appeals to Governments to reconsider their positions urgently to enable the Secretary-General to report on the matter to the General Assembly at its fortieth session, in view of the present crisis in Africa, which has as one of its major causes the process of desertification;
7. Urges Governments, organizations and bodies within the United Nations system, international intergovernmental and non-governmental organizations and training and research institutions to intensify their efforts to prevent and combat desertification in the years ahead, and in particular to accord high priority to the actions recommended by the Council in decision 12/10;
8. Notes the significant role that non-governmental organizations are playing in many of the more successful anti-desertification efforts, and calls upon Governments and international organizations, including the United Nations Environment Programme, to explore opportunities for utilizing them to a greater degree;
9. Invites the Executive Director to consult each of the principal international organizations which are funding desertification control activities, including the World Bank and the regional development banks, the United Nations Development Programme, the International Fund for Agricultural Development, the international centres for agricultural research and the Club du Sahel, to ascertain how the Environment Programme can best assist and facilitate those efforts, and to recommend to the Council at its fourteenth session measures that can be taken to enhance the effectiveness of co-operation between the Environment Programme and those institutions;
10. Welcomes the enhanced mandate given to the Consultative Group for Desertification Control and reiterates its invitation to all Governments, and particularly those of donor members, to become more involved in the work of the Consultative Group;
11. Invites the Consultative Group to pursue more vigorously its dual role of contributing information, policy and programme analysis and guidance on programme priorities to the Executive Director, as well as supporting his efforts to secure financial resources for activities proposed by developing countries, all within the framework of the implementation of the Plan of Action;

12. Welcomes the action taken by the Executive Director to establish the Desertification Branch as a programme activity centre in compliance with decision 121/10;

13. Approves the measures recommended to enhance the work of the Inter-Agency Working Group on Desertification and endorsed by the Administrative Committee on Co-ordination, as reflected in the Committee's report, and urges all members of the Working Group to put those measures into action immediately;

14. Stresses the vital importance of ensuring continuity of representation in the Working Group through designation of one or more representatives in the Group, each of whom would also serve as a focal point on desertification matters in his agency;

15. Urges all Governments to promote discussion of the implementation of the Plan of Action in the intergovernmental fora of members of the Working Group;

16. Requests the Executive Director to take appropriate action to invite international organizations outside the United Nations system to participate in meetings of the Working Group where the discussion would benefit from their presence;

17. Further requests the Executive Director to consider the inclusion of the member States of the Southern African Development Co-ordination Conference in the list of countries eligible to receive assistance through the United Nations Sudano-Sahelian Office, acting on behalf of the United Nations Environment Programme, in combating desertification;

18. Urges the Executive Director to intensify efforts, in consultation with other United Nations bodies and donor countries, to initiate concrete steps to seek alternative sources of funding to assist the countries of the Southern African Development Co-ordination Conference in particular;

19. Requests the Executive Director to report to it at its fourteenth session on the implementation of the present decision.

B. Implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian region

The Governing Council

1. Welcomes the steps taken by the United Nations Sudano-Sahelian Office, on behalf of the Environment Programme, toward the implementation of the Plan of Action to Combat Desertification in 21 countries of the Sudano-Sahelian and neighbouring region;

2. Authorizes the Executive Director to continue support to the Office as a joint venture with the United Nations Development Programme;

3. Urges the Executive Director and the Administrator of the United Nations Development Programme to consolidate the achievements realized so far by the Office and to intensify efforts to mobilize resources for continued assistance to the countries served by the Office in combating desertification;



4. Decides to include the United Republic of Tanzania in the list of countries eligible to receive assistance through the Office on behalf of the Environment Programme in implementing the Plan of Action;

5. Authorizes the Executive Director to submit his report on the implementation of the Plan of Action in the Sudano-Sahelian region, on behalf of the Council, through the Economic and Social Council, to the General Assembly at its fortieth session.

13/32. Regional and subregional programmes in Latin America and the Caribbean

The Governing Council,

... 1. Expresses its appreciation to the Government of Mexico for its kind hospitality in convening the Fourth Intergovernmental Regional Meeting on Environment in Latin America and the Caribbean;

2. Calls on the Governments of the region and the United Nations Environment Programme to ensure that future intergovernmental meetings include an agenda item aimed at strengthening the dialogue on the relationship between economic and social issues and the application and development of environmental policies which by their nature are cross-sectoral and global;

3. Requests the Executive Director to support the regional and subregional programmes of common interest and periodically to assess progress made in them, in co-operation with regional and subregional bodies, communicating the results of such assessments to the Governments of the region;

4. Invites the Governments of the region to conduct quantitative and social cost-benefit environmental studies which will serve as a basis for guiding national policies and to prepare regional reports on the state of the environment;

5. Requests the Executive Director, in co-operation with Governments and appropriate regional bodies, to focus his efforts, in this first stage of the implementation of the regional and subregional priority programmes identified at the Second Intergovernmental Regional Meeting on the Environment in Latin America and the Caribbean, held in Buenos Aires in 1983, on initiating the implementation of the regional environmental programmes on planning and environment, environmental law and environmental education, without prejudice to programmes already under way, namely, the regional seas programmes for the wider Caribbean and for the South-East Pacific and the Environmental Training Network;

6. Requests the Executive Director to report to Governments periodically on progress in ongoing programmes and their short-term prospects, including their financial aspects. In this regard, the intergovernmental regional meetings should include in their agenda analyses of project implementation in the preceding biennium;

7. Requests the Executive Director to support, within the resources allocated to the relevant budget lines, the implementation of the above-mentioned activities;

8. Further requests the Executive Director, with regard to the implementation of activities in the field of planning and the environment, to seek additional resources through the Clearing-house or through any other suitable mechanism as described in the present decision;

9. Recommends to the Executive Director that he should conduct an inventory of the available resources of regional and international multilateral organizations and bilateral sources to support the regional environmental programmes of common interest and to create and maintain an information system on such resources;

10. Recommends to the Executive Director that he should request countries, within a period of three months, to send him a list of experts from Latin America and the Caribbean in order to draw up a roster of such experts, with a view to supporting the implementation of the activities related to the application of the regional and subregional projects which are allocated priority within the framework of the regional programmes already adopted, bearing in mind in particular salaries of the experts for the period for which they are engaged, and the United Nations Environmental Programme is expected, within available resources, to meet their travel and subsistence expenses;

11. Authorizes the Executive Director, in the light of his report on innovative means of financing and alternatives for utilization of national currencies and contributions in kind to support the implementation of regional environmental programmes of common interest, within available resources and in co-ordination with appropriate regional and international United Nations bodies, to initiate actions which offer the Governments of the region alternatives concerning the use of national currencies in the implementation of environmental projects of common interest;

12. Urges the Executive Director, in preparing his plan for intraregional financing for selected regional and subregional environmental programmes, to take into account the proposal made by the experts of Ad hoc Meeting on Alternative Means for Financing in National Currencies and Contributions in Kind, held at Mexico City, in January 1985, and to prepare an appropriate timetable covering the stages suggested in the experts' proposal;

13. Recommends to the Executive Director that he should consider the possibility of making more use of non-convertible currencies from outside the region to support the programme referred to above.

... 1. Encourages Governments to promote the commercial exchange and transfer of environmental protection technology, and direct industrial contacts in the field of environmental protection technology;...

... 3. Encourages Governments to share public research and demonstration results and information on non-proprietary environmental protection technology;

4. Invites the Executive Director to consult Governments to identify specific environmental protection technology that is not now available to them, identify the reasons for such unavailability and report to the Governing Council at its next regular session on these matters, with recommendations to relevant bodies to discuss solutions to factors impeding appropriate transfer;

5. Invites the specialized agencies and other members of the United Nations system dealing with problems of technology transfer, in particular the United Nations Industrial Development Organization and the United Nations Conference on Trade and Development and regional economic commissions to take account in their respective fields of activity of the promotion of the transfer of environmental protection technology.

14/21. Regional and subregional programmes in Latin America and the Caribbean

The Governing Council,

1. Expresses its gratitude to the Governments of Mexico, Uruguay, Colombia and Jamaica for hosting the above-mentioned regional and subregional meetings;

(a) To support the work of the Contact Group of the Regional Office for Latin America of the United Nations Environment Programme headquarters, in conformity with the interest shown by the Governments in the regions, as reflected by the Final Report of the Fifth Intergovernmental Regional Meeting;

(b) To continue to promote technical co-operation among the countries of the region, especially that aimed at the dissemination of experience and achievements, as well as the training of professional specialists in environmental matters;...

(e) In connection with the Programme of the Environmental Training Network:

(i) To extend the duration of project FP/8102-86-02 (2676), entitled "Support to the regional co-operation project for the implementation of the environmental training network for Latin America and the Caribbean";

(ii) To incorporate the training components of the regional environmental programmes and projects into the General Programme of the Network and co-ordinate them through their regional co-ordination mechanisms;

- (iii) To continue supporting the Regional Co-ordination Mechanism, so that it can effectively fulfil the functions assigned to it by the Network Advisory Committee;
- (iv) To contribute to the support of the Regional Co-ordination Mechanism, should the Government of Mexico discontinue its generous contribution and if a formula for financing by the countries has not been established;
- (f) To advise Governments on how to obtain financial resources from the clearing-house mechanism and from other international organizations to support the umbrella projects and the national sub-projects;
- (g) To ensure that all future requests for new projects and activities which UNEP may promote in the region are considered within the regional co-operation system on environmental matters that the Governments of Latin America and the Caribbean have been establishing through their intergovernmental regional meetings;
- (h) To ensure that requests for new regional projects and activities which are supported by the United Nations Environment Programme are considered to be within the scope of priority of the Intergovernmental Regional Co-operation System on Environmental Matters that the Governments have been establishing through their intergovernmental regional meetings;
- (i) To take into account the interest of the region in a new regional programme of common interest on environmental management and utilization of agricultural and agro-industrial residues, as well as a new subregional programme on the management of grassland ecosystems in temperate subhumid and humid zones;
- (j) To continue with the Governments that have made progress in this field to promote the systemization of environmental legislation by means of national digests and the operation of data banks in the countries of the region interested in this field;
- (k) To give special attention to research programmes that will respond to the numerous questions about the behaviour of environmental systems and that will work towards the creation of methodological instruments for assessing environmental impact and for economic analysis;
- (n) To continue supporting the Food and Agriculture Organization of the United Nations/United Nations Environment Programme project on the management of wildlands, protected areas and wildlife, in accordance with the guidelines of the present project, which includes training, support for the Latin American Network of Technical Co-operation for the Protection of National Parks, Other Protected Areas and Wild Flora and Fauna, technical co-operation and information bulletins on the subject, including activities in the following matters:
  - (i) Harmonization of the relations between the objectives of the protected areas and those of the inhabitants of such areas, local societies and economies;
  - (ii) Relationship between the management of protected areas and that of neighbouring wildland areas;



- (iii) Operational and methodological co-ordination in the conservation of the natural and cultural heritage in protected areas where both exist.

2. Further requests the Executive Director to report to the Governing Council at its next regular session on the results of this investigation.
