Introduction

- 1. Following the recommendations of the 14th Meeting of the Contracting Parties held in Portoroz in November 2005, the Secretariat has prepared a proposal on a new reporting format of MAP. It was decided that the new reporting format should be prepared by the Secretariat in close consultation with the CPs and regional and international competent organizations. In order to review the proposed new format, the Secretariat will convene a meeting with experts on reporting. The meeting will be held at Hotel Armada (Ahirkapi Str. No:24, 34122 Sultanahmet, Istanbul, Turkey Tel:+ 90 212 455 44 55 Fax: + 90 212 455 44 99).
- 2. The following annotations to the provisional agenda were prepared by the Secretariat to assist the meeting in its deliberations.

Agenda item 1: Opening of the meeting
