(iii) Preparations for UNEA-5, including a possible scoping exercise and/or timetable for the tabling of resolutions

The Committee will be invited to consider the status of preparations for UNEA-5, including with regard to format and structure of UNEA-5, the theme of the High Level Segment and the scope and timetable for the tabling and consideration of draft resolutions for UNEA-5, based on documents UNEP/CPR/SC2020/5, UNEP/CPR/SC2020/6 and UNEP/CPR/SC2020/7.

#### (iv) Preparations for UNEP@50

The Committee will be invited to consider the preparations for the 50-year commemoration, as mandated in paragraph 10 of UNEA Decision 4/2 (UNEP@50), based on document UNEP/CPR/SC2020/8.

The Committee will consider the implementation of UNEA resolution 4/22 entitled "Implementation and follow up of UNEA resolutions", based on a Secretariat presentation and launch of the new online UNEA Monitoring and Reporting Portal.
