Agenda Item 5(iii): Preparations for UNEA-5, including a possible scoping exercise and/or timetable for the tabling of resolutions

Following the consideration of the timing and format of UNEA-5 in view of COVID-19 by the <u>UNEA Bureau</u> at its meeting on 8 October, the UNEA Bureau decided to support the <u>proposal by the UNEA President</u> to adopt a "two-step" approach that will allow for the convening UNEA-5 in February 2021 at the dates previously agreed in a virtual format with a revised and streamlined agenda.

The UNEA Bureau also requested the Secretariat to propose a structure for the first part of UNEA-5 in February 2021 for consideration at the 7th annual subcommittee and thereafter, on the basis of feedback from Member States, to the next meeting of the Joint Bureaux of UNEA and of the CPR, scheduled for 1 December 2020.

To this end the Secretariat has developed a preliminary structure for UNEA which contemplates an early adjournment of the session and indicates the main elements and items to be considered. In addition, the Secretariat has included the provisional agenda for the Assembly which indicates the items that are recommended to be addressed at the resumed substantive session in February 2022.

Finally, in light of feedback from Member States the Secretariat recommends that the commemoration of the creation of the United Nations Environment Programme in 1972 be inscribed as a supplementary item in accordance with rule 11 of the Rules of Procedure to be considered at the resumed substantive session

Member States are invited to consider the attached draft revised provisional agenda and structure for UNEA-5 and provide feedback and guidance to the Secretariat in view of preparing for further consideration of this matter at the next meeting of the Joint Bureaux of UNEA and of the CPR, scheduled for 1 December 2020.
