Introduction

1. In accordance with the UNEP/MAP Programme of Work 2020-2021 adopted by the 21st Ordinary Meeting of the Contracting Parties to the Barcelona Convention and its Protocols, Naples, Italy, 2-5 December 2019, the Secretariat is organizing the Integrated Meetings of the Ecosystem Approach Correspondence Groups on IMAP Implementation (CORMONs), on 1-3 December 2020, via videoconference.

- 2. The main objectives of the Meetings are to:
- Take stock of the progress made, review proposals and provide guidance on specific matters related to the implementation of the 2023 Mediterranean Quality Status Report (2023 MED QSR) Roadmap and the delivery of the 2023 MED QSR.
- (ii) Report progress under ongoing and new projects to boost IMAP implementation in the Mediterranean.
- (iii) Review a number of technical documents related to key aspects of the IMAP implementation under the Pollution, Marine Litter and Biodiversity and Fisheries Clusters.
- (iv) Review good practices in relation to integrated approaches to IMAP monitoring and assessment.
- (v) Define concrete ways and means to strengthen Science-Policy Interface in the region to support IMAP implementation in the context of the Ocean Decade for Science.

8. The discussions will be held in plenary sessions, as well as in break-out sessions for discussions pertaining to each thematic CORMON.

Under this agenda item, the Secretariat will present documents "Implementation of the 2023 MED QSR Roadmap" and "Issue Paper for 2023 MED QSR Development Approach and Structure" (UNEP/MED WG.482/3 and UNEP/MED WG.482/4), providing an update on the implementation of the 2023 MED QSR Roadmap, and on the progress towards the preparation of the 2023 MED QSR. 14. Under this agenda item, the Secretariat will provide an overview of ongoing and recently launched EU-funded projects contributing to the implementation of IMAP, namely the "Towards achieving the Good Environmental Status of the Mediterranean Sea and Coast through an Ecologically Representative and Efficiently Managed and Monitored Network of Marine Protected Areas" (IMAP-MPA); "Support to Efficient Implementation of the Ecosystem Approach-based Integrated Monitoring and Assessment of the Mediterranean Sea and Coasts and to delivery of data-based 2023 Quality Status Report in synergy with the EU MSFD" (EcAp MED III); and "Marine Litter Med II" projects, focusing on their respective activities in support of IMAP implementation, as part of and in complementarity with the UNEP/MAP 2020-2021 Programme of Work activities.

15. The Meeting is expected to take note of the progress achieved and provide concrete recommendations for the implementation of IMAP and reaffirm the Contracting Parties' commitment in the implementation of the project activities, in particular those implemented at national level.

16. Under this agenda item, the Secretariat (MED POL) will first present the documents "Monitoring Guidelines/Protocols for Floating Microplastics" and "Updated Baseline Values and Proposal for Threshold Values for IMAP Common Indicator 22" (UNEP/MED WG.482/19 and UNEP/MED WG.482/23), in line with the 2023 MED QSR Roadmap implementation.

17. The Meeting is expected to discuss and endorse the documents and provide guidance to the Secretariat on the next steps to be followed with regard to the marine litter related IMAP implementation, as appropriate.

18. The Coordination team of the EU-funded INDICIT-II project will present project outcomes related to marine litter impact indicators and GES proposals, including the monitoring procedure, the evaluated impacts, GES scenarios, as well as proposals for further synergies with the work of the Marine Litter CORMON, in particular with regard to spatial analyses at the Mediterranean level.

19. The Secretariat (MED POL) will present the proposal of the Monitoring Guidelines/Protocols related to IMAP Common Indicators 13, 14, 17 and 20 (UNEP/MED WG.482/5- WG.482/18). The monitoring guidelines are structured around specific protocols that elaborate the methodologies and practices of relevance for strengthening of the capacities of IMAP monitoring network with regards to

sampling and sample preservation; sample preparation; analytical quality assurance and reporting of monitoring data.

20. The Secretariat (REMPEC) will present the Revised Guidance Fact Sheets for IMAP Common Indicator 19 (part of UNEP/MED WG.482/21). The proposed revisions take into account the conclusions of the Mediterranean 2017 Quality Status Report, the study on trends and outlook of marine pollution from ships and activities and of maritime traffic and offshore activities in the Mediterranean, and other documents of on-going processes, relating to elements directly or indirectly linked to maritime traffic, and offshore activities.

21. The Meeting is expected to discuss and endorse the documents, as appropriate, and make recommendations on the way forward.

22. The Coordination team of the EU-funded MedRegion project will present key outcomes related to the pollution cluster of IMAP.

Under this agenda item, the Secretariat (SPA/RAC) will present the documents "Update of Monitoring Protocols on Benthic Habitats" (UNEP/MED WG.482/20) and "Comparative Analysis Undertaken with regard to IMAP and the European Commission GES Decision 2017/848/EU for Biodiversity" (UNEP/MED WG.482/25). The Secretariat (REMPEC) will then present the part of the document "Revised Guidance Fact Sheets for IMAP Common Indicators 6 and 19" (UNEP/MED WG.482/21), related to Common Indicator 6. The Secretariat (INFO/RAC) will also present the document "Data Dictionaries and Data Standards for the Common Indicators 3, 4 and 5 related to Marine Mammals, Marine Turtles and Sea Birds (Draft)" (UNEP/MED WG.482/22).

25. The Secretariat (PAP/RAC) will present possible approaches to integrated GES assessment and integrated measures to achieve GES through the application of ICZM and Common Regional Framework (CRF) and integrated IMAPs at national levels. Emphasis will be placed on the CRF

Methodological Framework i.e. matrix of interactions between the ICZM Protocol provisions, the main regional strategic and policy documents, and EOs and the corresponding methodological guidance for reaching GES that is built on the principles of integration and cumulative impact. The method, as well as its practical application in Slovenia, will be presented.

26. The Secretariat (PAP/RAC) will also present activities under GEF Adriatic in Montenegro highlighting in practical terms the integration and cross-cutting nature of EOs. This presentation will provide a demonstration of how integrated national IMAP can be elaborated, interlinking all EOs/indicators, responsible institutions, and addressing very practical implementation issues. An example of the preparation of MSP at a large scale using most IMAP indicators will be presented, demonstrating the application of MSP as an instrument through which measures to achieve GES are elaborated and adopted by the decision makers.

27. The Meeting is expected to discuss cross-cutting issues and provide recommendations for further actions towards integrated GES assessment within 2023 MED QSR.
