Annotated provisional agenda

- 1. Opening of the meeting. The meeting will be opened by Prof. S. Busuttil, MAP Coordinator. Mr. A. Pavasovic, PAP Director, will also address briefly the participants. Attendance of NFPs and other participants will be registered.
- 2. <u>Rules of Procedure</u>. The meeting will take note that according to <u>UNEP-MAP</u> regulations, the Rules of Procedure contained in document <u>UNEP/IG.43/6</u> Annex XI will be applied.
- 3. <u>Election of officers</u>. One chairman, two vice-chairmen and a rapporteur will be elected among the participants representing NFPs for PAP. A secretary of the meeting will also be nominated.
- 4. Adoption of the agenda. The meeting will discuss the provisional agenda as reflected in the document UNEP(OCA)MED/WG.38/1 and adopt the final agenda.
- 5. Brief review of PAP development in 1983-91. Since in the period 1990-92 a number of PAP NFPs have been changed, a need was felt to present an information on the earlier activities and development of PAP. The PAP Director will briefly introduce the documents UNEP(OCA)MED/WG.38/Info.1, Info.2, and Info 3.
- 6. Report on the implementation of PAP in 1992-93. This report will be presented and discussed in three parts, namely:
 - 6.1 PAP activities related to integrated planning and management of Mediterranean coastal zones and PAP involvement in MAP CAMPS (UNEP(OCA)/MED/WG.38/4.1). Mr. I. Trumbic, Assistant Director of PAP, will present the document to the participants.
 - 6.2 <u>Implementation of PAP cooperative projects</u>:
 - on water resources management (UNEP(OCA)/MED/WG.38/4.2) to be presented by PAP Director and the representative of Malta. Also a proposal for the programme of training activities in Malta (UNEP(OCA)/MED/WG.38/Info.4) will be presented;
 - on soil erosion (UNEP(OCA)/MED/WG.38/4.3) will be presented by the representative of FAO and PAP Director;
 - on seismic risk mitigation (UNEP(OCA)/MED/WG.38/4.4) will be presented by the representative of UNDRO and PAP Director. Proposals for the follow up of this project and MAP/PAP participation will also be discussed.

6.3 <u>Implementation of individual priority actions</u> (UNEP(OCA)/MED/WG.38/4.5) will be presented by PAP Director.

The participants will be invited to comment on the presented document, to evaluate the achieved results, and to make recommendations for the follow up.

- 7. Other business. The meeting will discuss and make recommendations for any other relevant issue, if raised.
- 8. Adoption of the meeting report. The secretariat will present the draft Report, which will be discussed and adopted with relevant amendments.
- 9. <u>Closure of the meeting</u>. The meeting is expected to be closed by the Chairman on November 25 at 2 p.m.
