The participants of the Meeting will be expected to comment upon each of the chapters of the document UNEP/WG.11/3.

Document UNEP/WG.11/4 (Prov.) will be introduced by the UNEP Programme Co-ordinator of the Co-ordinated Mediterranean Pollution Monitoring and Research Programme. Participants will be asked to review and comment upon this document chapter by chapter and to offer suggestions for the improvement of the document, taking into account the discussion on the previous agenda item.
