The work program of the Compliance Committee for the biennium 2014-2015 adopted by the Eighteenth Meeting of the Contracting Parties provides for the finalization of the common criteria and guidelines for the assessment of reports by the Compliance Committee.

During its 7th meeting, the Committee gave its consent so that, in the framework of the assessment of reports submitted by the Contracting Parties, assessment criteria are set for the biennium 2010-2011 and asked Mrs. Daniela Addis to pilot a Working Group to collect propositions of amendment or complements to the draft information note setting these guidelines.

At its 8th Meeting, the Committee welcomed the presentation of Mrs. Daniela Addis of propositions of amendments and complements to the draft information note setting "The Guidelines for the assessment of reports to identify the current or potential situations of non-compliance". The Committee is expected to provide comments on this amended version to finalize it accordingly.

In its activity report for the Biennium 2010-2011, the Compliance Committee deplored the partial information and the too general responses to the Questionnaire and underlined the necessity to proceed with a revision of the reporting format for the purposes of simplification. Taking note of the proposition of the Committee, the Eighteenth Meeting of the Contracting Parties requested, by virtue of Decision IG.21/2, the Secretariat to prepare, in consultation with the Compliance Committee, a practical and simplified draft of the reporting model and submit it for examination and adoption at the Nineteenth Meeting of the Contracting Parties.

The President will invite the Secretariat to present the explanatory note on the study regarding the review of the current reporting format for the Committee's comments. The draft reviewed Reporting format reflecting these comments will be submitted to the Committee members electronically before the 10th Meeting of the Compliance Committee.
